## A. Winter Break Adventure Camp

Tesser discussed planning the winter camp again this year. Since Christmas is on a Tuesday this year the camp will have to be on Wednesday, Dec 26<sup>th</sup> through Dec 28<sup>th</sup>. The activities planned are snowshoeing, ice skating, snow coloring and other fun activities. Tesser will ask Roseville Nature Center for the use of snowshoes which is a cost of \$2.00 for each pair. The cost of the camp will be \$55.00 for residents and \$62.00 for non-residents. Tesser has two very experienced Rec Leaders who will staff the camp. One staff person ran Summer Discovery Camp in the summer. Tesser is currently advertising but snow is important to vitality of the program.

#### B. Warming House attendants

Tesser received three applications for rink attendants. There will be three returning attendants but they have limited schedules. Tesser is interviewing the first week of December. The rink will open December 23<sup>rd</sup>, if weather is cooperative.

### C. Winterfest Event

Tesser has confirmed with Joel, owner of Suomi Kennel, to attend our event. His dog's will give rides to 2-3 people at a time. The cost is \$900.00 which includes mileage. Joel requested the snow to be packed down before the event and requires two volunteers to help with the lines. Tesser mentioned ski joiring as something to do next year, Three Rivers District teaches classes and would come out to the event to show people how to ski joir.

Commissioners suggested having snow shoeing at the event. In the past, the trailer of youth skies had snow shoes as well. Tesser will look into whether the ski youth group still has snowshoes available for use.

## D. OLLI Learning

Tesser discussed the new classes that will be at the Falcon Heights City Hall. By the city providing space, residents are able to take these classes for a small fee of \$5.00. Below are the classes this semester.

#### **Understanding Criminal Justice in America**

Most people understand the criminal justice system on an anecdotal basis and from what they see and read in the media. This limited contact causes confusion and raises questions. This course presents an overview of the components of the system, and examines the issues within system decision-making and their consequences. #### **Looking Inside the Human body**

## 5. Noxious Weed Planning

Mayor Pete Lindstrom asked Tesser to have the Parks Commission draft a noxious weed plan that should incorporate sustainable initiatives to eliminate weeds from the parks such as: thistles and buckthorns. Tesser brought forward different noxious weed plans and also how the DNR handles noxious weeds. Commissioners discussed what exactly they should be drafting. Tesser brought up that she would like to see a section on Volunteering/Outreach and that she has begun to talk to the Girl Scouts about cleaning up Curtiss Field on a yearly basis in exchange for renting our Council Chambers and Community Park facility. Chair Weber-Sanders discussed her thoughts on the Environment Commission being involved in the planning. Commissioners also wanted to know what was done currently in eliminating/managing weeds. Pittman was absent and Tesser did not know the process. Commissioners also thought coming up with goals would be helpful as a starting point. The commission concluded that they would table the discussion until Pittman returns at the next meeting.

## 6. Curtiss Field Park Time Closure and Sign Change

Tesser was contacted by a resident who lives adjacent to Curtiss Field about a variety of complaints, one being that she would like the park to be closed earlier than 10:00pm. The resident alleges that kids are at the park very late and are up to no good. The resident thinks closing the park earlier may help decrease this behavior. Commissioners were concerned about the cost of sign replacement and if the hours should be changed based on one person's complaint. Tesser will ask the SAPD to pull all police reports from Curtiss Field from the last couple of years and will also do a survey of other cities park closure times.

## Park Buildings Handicapped Accessibility Requirements

Chair Weber-Sanders researched handicapped accessibility requirements (ADA) for park buildings. She concluded that the park buildings are not in compliance to the ADA regulation. Tesser looked at the ADA regulations and into the age of each park building and found that the city is grandfathered in because their buildings were built in 1991. According to the ADA, the city does not have to alter their buildings to comply unless a replacement is needed. Tesser will discuss this with Tim Pittman and City Administrator Fischer so they are aware of the ADA requirements if any future work is required.
