STOP & TALK (City Mtgs, patrol city/parks, etc)	Extra patrol due to recent complaints.
PROP DAMAGE-MS-PUBLIC-UNK INTENT	Curtiss Field pavilion had a broken window. Unknown suspects.
PROP DAMAGE-MS-PUBLIC-UNK INTENT	Damage to window on the park building. Appeared to have been caused by a bebe gun. Information received on a 20 year old male suspect.
