TOTAL LEVY	\$2,137,524

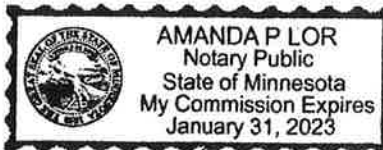


