RESOLUTION SELECTING NORTHLAND RECREATION AS THE PLAYGROUND SUPPLY AND INSTALLATION CONTRACTOR THROUGH A JOINT PURCHASING COOPERATIVE NOT TO EXCEED \$250,000

WHEREAS, the City of Falcon Heights approved Resolution 24-62 to release a Request for Proposal (RFP) to accept playground proposals from October 31 through 1:00 p.m. on November 26, 2024 from qualified playground manufacturing representatives; and

WHEREAS, pursuant to advertisement for proposals according to the plans and specifications outlined within the RFP and published in the *Pioneer Press*, the official newspaper, the City's website, and the e-advert bidding platform, said proposals were received on November 26, 2024 digitally, opened and evaluated for the best design and a total of eleven proposals were received from seven playground manufacturing representatives who serve Minnesota and complied with the advertisement;

WHEREAS, the Parks and Recreation Commission met on December 2, 2024 to narrow the submitted proposals down to their top three selections and to make a list of requested revisions to then make a recommendation to City Council, with Northland Recreation voted the Commission's most preferred design due to inclusivity and consideration of ages and mobilities served; and

WHEREAS, the City Council reviewed the Parks and Recreation Commission's selections at a Workshop meeting on December 4, 2024 and had no other revisions to request from the vendor; and

WHEREAS, Staff then requested the Parks and Recreation Commission's revisions from the Commission's top choice, Northland Recreation; and

WHEREAS, Northland Recreation revised its proposal to update it with the requested changes made; and

NOW THEREFORE BE IT RESOLVED by the Council of the City of Falcon Heights, Minnesota:

1. The Mayor and City Administrator are hereby authorized and directed to utilize a joint purchasing cooperate to enter in to an agreement with Northland Recreation, not to exceed \$250,000.00 in the name of the City of Falcon Heights for the above improvements,

- according to the plans and specifications thereof, heretofore approved by the City Council and on file in the office of the City Administrator.
- 2. The City Administrator is hereby authorized to further modify the plans as needed up-to the figure of \$250,000.00 without further council approval.
