#### C. APPROVAL OF AGENDA

Vice-Chair Pellegrini made a motion to approve the agenda. All were in favor. Agenda was approved by consent.

#### D. APPROVAL OF MINUTES

#### 1. October 14, 2024

Vice-Chair Pellegrini made a motion to approve minutes from the October 14, 2024 meeting. All were in favor. Minutes were approved by consent.

#### E. NEW BUSINESS

#### 1. Tree Trust Information - Karen Zumach

Karen Zumach from the Tree Trust presented information on the organization and tree sales with communities. The Tree Trust was founded in 1976 when Dutch Elm Disease was rampant. It was an organization which aimed to remove diseased or otherwise damaged trees and replace them. They work with youth, young adults, and other residents, and focus on employment training, for-profit landscaping services, community forestry, and volunteer organization for tree plantings.

She spoke about tree sales and explained that the Tree Trust organizes the sale, including a website, acquiring the tree stock, confirming orders, answering questions, and organizing pick-ups. They can also look at the City's tree canopy for gaps to allow the

City to potentially reach out to residents in those areas about purchasing trees. She stated the cost of the tree is generally between \$30 and \$70 for the resident, with the City covering \$100 to \$110. This includes the tree and mulch.

Environment commissioners discussed a potential tree sale and decided \$50'/tree would be a good price point for residents. Staff Liaison Lynch stated she would follow up with the City Administrator about organizing this with Tree Trust.

2. Undergraduate Leadership Program Students – Project Presentation Megan Cunningham, Madison Cocker, Janelle Barlan, and Ethan Cederberg, students from the University of Minnesota, presented a project around the University of Minnesota's golf course and potential future development of the site. Their goals for development include sustainability, affordability, and recreation. They spoke about Just Housing, a Duluth company that produces replicable and scalable homes that do not use any fossil fuels, as the type of home imagined for the site. Additionally, they discussed researching if the site would be suitable for geothermal energy and/or active solar and including recreational green space throughout the site. They hope to engage with residents and create a formal presentation including GIS maps and zoning information for their school project.

Staff Liaison Lynch thanked them for coming and informed them of the recently completed Snelling and Larpenteur Corridor Development Study. She encouraged them to look at the community input in that. She also advised them to be sure, if they reach out to residents, to be clear this is for a school project as the University of Minnesota has directly informed the City that there are no future plans for selling or developing the golf course.

#### 3. Plastic Bag Recycling

GreenCorps Member Olivia Siebert spoke about the feedback from residents in the Climate Action Plan survey about the desire for plastic bag recycling at City Hall. She has researched the ability to recycle these plastic bags outside of grocery stores and found a company called Merric, Inc. out of Vadnais Heights. They accept many hard-to-recycle products and charge \$10 for a load of recyclables to be dropped off.

Commissioners discussed and had questions about the reliability and suitability of the company, and expressed desire to make sure they are recycling the plastics. They also discussed the soon-to-open recycling center in Roseville and what will be able to be recycled there.

Commissioners discussed placement of the recycling bin(s) for the bags and decided outdoors would be best, in an accessible location for all residents. It was determined near the food scraps area would be the best option.

#### 4. Sustainability Fair

GreenCorps Member Olivia Siebert discussed the possibility of holding a sustainability fair near Earth Day in 2025. It would be indoors and consist of tables with information from organizations on a variety of sustainability topics, as well as possibly including a few speakers. She asked commissioners for ideas of organizations to reach out to.

Commissioners suggested topics such as reuse/repair, native plantings and gardening, and organizations such as: Friends of the Mississippi River, Reuse MN, Ramsey County Fix-It Clinics, tool library, the Horticulture Society, MetroTransit, local thrift stores, solar installers, bike shops, and others.

#### F. Information and Announcements

#### 1. Staff Liaison Report

Staff Liaison Lynch advised commissioners that December 10 is Human Rights Day and Just Deeds combined with the CEC is holding an event at City Hall to discharge racial covenants from deeds. She also gave a brief update on the status of the development of the climate action planning team.

#### 2. Council Liaison Report

Council Liaison Mielke advised commissioners that she heard from Christine Chitambar about the goldfish rehoming she and her son, Theo, have been working on. She stated the goldfish that were rehomed from the Community Park pond were not doing well, and another solution may need to be considered.
