| Description | The proposed 2010 budget factors in the establishment of a streetlight utility to be charged to all properties with in the City of Falcon Heights. This fee will be used to pay for all electricity and maintenance expenses that are associated with the streetlight system throughout the community. |
| | For the most part, there are two types of streetlights in the City of Falcon Heights. The first type is the standard gray cobra-head style that line most of our streets. These lights are maintained by Xcel Energy, but the electricity cost is paid by the city. The second type is the decorative green lamps along Larpenteur Avenue near the intersection of Snelling Avenue. The maintenance of these lamps (replacement bulbs, painting, etc.), as well as the electricity, is the responsibility of the city. |
| | The past practice of the city has been to pay for these expenses through the general fund, which is paid for by taxpaying properties within the city. However, roughly 2/3 of the city is tax-exempt, which means that these properties do not pay taxes into the city's general fund. Many of the lights abut these tax-exempt parcels, so they are receiving a benefit without paying for the expense. ORDINANCE NO. 10-01

AN ORDINANCE AMENDING CHAPTER 50 OF THE CITY OF FALCON HEIGHTS CITY CODE ESTABLISHING A CITY STREET LIGHT UTILITY SYSTEM

THE CITY COUNCIL OF THE CITY OF FALCON HEIGHTS ORDAINS:

SECTION 1. Chapter 50 of the Falcon Heights City Code is amended by adding Article IV to provide as follows:

50-60. STREET LIGHT UTILITY. A City street lighting utility system is hereby established and continued. The utility system consists of all street lighting whether owned by the City or otherwise, for which the City purchases and supplies electrical energy from a public utility and any additional facilities acquired or operated by the City in the future.

50-61. COST OF SYSTEM.

- A. The cost of the street lighting utility system are the administrative costs, capital costs, maintenance and energy costs associated with the operation of the street lighting utility system.
- B. The City Council shall by resolution establish a fee schedule to pay for the cost of the street lighting utility system. The City Council shall apportion the cost of the system against all developed property in the City. Single family residential property shall be charged based upon a per unit charge and all other property shall be charged based upon a front foot charge.
- C. Street lighting costs shall be billed with water bills.
- **50-62. CERTIFICATION OF UNPAID BILLS.** On or before October 1st of each year, the clerk must list the total unpaid charges for street lighting against each separate lot or parcel to which they are attributable. The Council will then spread the charges against property benefited as a special assessment under Minnesota Statutes, Section 429.101 and other pertinent statutes for certification to the County and collection the following year with real estate taxes.

50-63. STREET LIGHTING UTILITY FUND. All fees and assessments received pursuant to this Article shall be place in a dedicated fund for the purpose of paying the costs of the street lighting system.

SECTION 2. EFFECTIVE DATE. This Ordinance shall be effective immediately upon its passage and publication according to law.

AMENDMENT NO. 2 to AGREEMENT BETWEEN

BOARD OF WATER COMMISSIONERS and CITY OF FALCON HEIGHTS

This **AMENDMENT NO. 2 TO AGREEMENT** entered into this 9th day of February, 2010, by and between the **BOARD OF WATER COMMISSIONERS**, a municipal corporation of the State of Minnesota (the "Board"), and the **CITY OF FALCON HEIGHTS**, a municipal corporation of the State of Minnesota ("Falcon Heights").

WITNESSETH:

WHEREAS, Falcon Heights and the Board entered into an agreement dated July 9, 1997 for the provision of water service by the Board to properties within Falcon Heights (the "Agreement"); and

WHEREAS, Article XV of the Agreement allows for amendments to the original agreement, and

WHEREAS, Falcon Heights at this time desires that the Board provide street lighting fee ("Street Lighting Fee") billing and collection services to properties within Falcon Heights on its behalf, and the Board desires to provide such services in accordance with said Article XV.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties mutually agree to amend the Agreement in the manner described below.

- 1. The following Street Lighting Fee billing terms and conditions are hereby added to the Agreement:
 - A. Board Responsibilities
 - 1) The Board will provide current electronic account data to Falcon Heights to assist Falcon Heights in allocating Street Lighting Fees to water/sewer accounts.
 - 2) The Board will provide the work necessary to include Falcon Heights Street Lighting Fees in the Board's billing system. The Street Lighting Fee shall be appropriately displayed on the Board's water/sewer bill form.
 - 3) The Board will provide descriptive information on the water/sewer bill form regarding the Street Lighting Fee, as permitted by and within limitations of the Board's water/sewer bill form.

- 4) The Board will provide month-end reports to Falcon Heights, which will list the number of bills charged a Street Lighting Fee and the amount charged.
- 5) The Board will provide to Falcon Heights the Street Lighting Fee payments it collects, less compensation for providing billing services. Payments not received by the Board for the Street Lighting Fee may be withheld from monies due Falcon Heights until collection is made. The necessity of such withholdings will be determined by Board staff on a case-by-case basis, and such withholdings and collections will be included as a line item in the month-end reports to Falcon Heights.
- B. Falcon Heights Responsibilities
 - 1) Falcon Heights will provide the Board with the text it wishes the Board to include on the front and back of the water/sewer bill form.
 - 2) For each property to be billed a Street Lighting Fee, Falcon Heights will provide in an electronic format approved by Board: (1) water service account number, (2) the property address of the account, and (3) the amount of the Street Lighting Fee to be billed.
 - 3) Falcon Heights will inform its residents of the new Street Lighting Fee, how it is computed and that Saint Paul Regional Water Services will be performing the billing and collection.
 - 4) Board will refer all customer questions and inquiries regarding the Street Lighting Fee to Falcon Heights, which is responsible for addressing same.
- C. Schedule
 - 1) Falcon Heights and the Board agree to implement the Street Lighting Fee billing according to a schedule acceptable to both parties.
- D. Compensation
 - 1) Falcon Heights agrees to pay a billing fee of \$.12 for each water/sewer bill that includes a Street Lighting Fee charge. This fee shall increase over time at the same percentage rate as Board water rates.
- 2. Except as modified herein, the terms of the Agreement shall remain in full force and effect.

| Item | Tobacco Violation Penalty Schedule |

| Description | In late 2009, for the first time in several years, one of the city's licensed tobacco vendors received a penalty for selling tobacco to an underage person. When staff and legal counsel were discussing how to proceed with issuing a penalty for this infraction, it was discovered that specific terms were not outlined in the city code. Instead, the city relied on authority under state statutes and imposed a fine of \$500. In discussing this with other cities and the Ramsey Tobacco Coalition, it was found that most cities have a graduated penalty scale built into their city code for vendors that sell tobacco to underage persons. Attached to this report is an ordinance amendment that reflects comments received at the January 6 th city council workshop. It calls for graduated penalties of \$500 for a first violation, \$750 for a second violation, and license revocation for a third violation. The clerk or individual who commits the violation is also subject to a \$50 fine, per state statute. Once notified, license holders may request a hearing, but if no hearing is requested, the presumptive penalty will be imposed. |
| Budget Impact | Since the occurrence of these penalties is so rare, fines will not be projected in future operating budgets. |

ORDINANCE NO.

AN ORDINANCE AMENDING CHAPTER 14 OF THE FALCON HEIGHTS CITY CODE CONCERNING TOBACCO

THE CITY COUNCIL OF FALCON HEIGHTS ORDAINS:

SECTION 1. Section 14-297 of the Falcon Heights City Code is amended by adding the following provisions:

- (c) Administrative Civil Penalties; Licensee: Each license issued hereunder shall be subject to suspension or revocation for violation of any provisions of this chapter or the laws of the State of Minnesota as follows:
 - (1) First Violation: The first violation of this chapter shall be punishable by a civil penalty of five hundred dollars (\$500.00).
 - (2) Second Violation: A second violation of this chapter within any twenty four (24) month period shall be punishable by a civil penalty of seven hundred fifty dollars (\$750.00).
 - (3) Subsequent Violation: A third or subsequent violation of this chapter within any twenty four (24) month period shall be punishable by revocation of the license. Any licensee whose license is revoked under this section shall not be eligible for renewal for a period of two (2) years after the revocation.
- (d) Administrative Civil Penalties; Individuals: An individual who sells tobacco to a person under the age of 18 years shall pay an administrative penalty of fifty dollars (\$50.00).
- (e) Hearing: Following receipt of a notice of a violation and penalty issued under this section, the license holder or individual may agree to the presumptive penalty or request a hearing before the City Council. A request for a hearing shall be made by the individual or license holder in writing and filed with the City Administrator or designee within ten (10) days of the mailing of the notice of the alleged violation. Following receipt of a written request for hearing, the individual or license holder an opportunity for a hearing before the Council.
- (f) Findings: If after the hearing the license holder or individual is found in violation of this chapter, the Council shall impose the presumptive penalty.

(g) Default: If the individual or license holder has been provided written notice of the violation and if no request for a hearing is filed within the ten (10) day period, then the presumptive civil penalty, suspension or revocation imposed in this chapter shall take immediate effect by default. The City Administrator or designee shall mail notice of the fine, suspension or revocation to the individual or license holder.

SECTION 2. This ordinance shall be effective immediately upon its passage and publication.

WHEREAS, the "Complete Streets" concept promotes streets that are safe and convenient for all users, including pedestrians, bicyclists, transit riders, and motor vehicle drivers of all ages and abilities; and

WHEREAS, the October 2009 public draft of the Minnesota Department of Transportation *Complete Streets Report* includes the recommendation: "Mn/DOT should build on existing Context Sensitive Solution practices and develop and implement a statewide Complete Streets policy..."; and

WHEREAS, the Falcon Heights City Council recognizes the importance of complete streets, as shown in its 2008 Comprehensive Plan update;

NOW, THEREFORE BE IT RESOLVED, that the City of Falcon Heights encourages the Minnesota legislature, with input and guidance from the Minnesota Department of Transportation, to authorize the development of a statewide Complete Streets program, which would provide for the development of a balanced transportation system, through appropriate planning, that integrates multiple transportation modes, where appropriate, for transportation users of all types, ages and abilities.

Background Related to Complete Streets

- Complete Streets is a flexible transportation planning and design process that considers the safety and accessibility needs of all users. Complete Streets is not a prescriptive roadway design. Individual "complete" street designs vary based on context, including topography, road function, the speed of traffic, pedestrian and bicycle demand, local land use, and other factors.
- State Senator Tony Lourey (Kerrick) and State Representative Mike Obermueller (Eagan) will introduce Complete Streets legislation during the 2010 legislative session.
- The Minnesota Department of Transportation (Mn/DOT) is working to create a partnership of state agencies, local governments, and other stakeholders to develop and implement a Mn/DOT policy on Complete Streets.
- In December 2009, Mn/DOT released a legislatively mandated <u>Complete Streets</u> <u>Report</u>, which includes a recommendation for Mn/DOT to work in partnership with representatives of relevant stakeholders to develop a Complete Streets policy. The report also articulates the important connection between Complete Streets and Context-Sensitive Solutions, which together support building roads that better fit local needs and contexts and help save money.
- Mn/DOT Commissioner Thomas Sorel has spoken publicly about the benefits of Complete Streets and his commitment to taking a leadership role on implementation of a Complete Streets policy.
- Between 1999 and 2008, 417 pedestrians and 84 bicyclists were killed and more than 10,000 pedestrians and more than 9,000 bicyclists were injured on Minnesota's roads.
- Complete Streets is a national movement with policies adopted by 12 states and more than 100 cities and counties, including Rochester, Hennepin County, St. Paul, and Albert Lea.
- The Centers for Disease Control and Prevention, Minnesota Department of Health, Blue Cross and Blue Shield of Minnesota, American Heart Association, HealthPartners, and other public health officials in Minnesota and across the country have called for Complete Streets as an important public health tool in fighting the obesity epidemic by supporting exercise as a part of daily life.
- The Complete Streets concept is also supported by AARP, Urban Land Institute of Minnesota, Minnesota Consortium for Citizens with Disabilities, Minnesota Environmental Partnership, and many other transportation, planning, and public

health professionals. The <u>Minnesota Complete Streets Coalition</u> has more than 45 member organizations that support the concept of Complete Streets and a state Complete Streets policy.

Benefits of Complete Streets

- Complete Streets improves safety by reducing crashes and injuries and their costs.
- Complete Streets removes barriers to transportation facilities and services for seniors, children, and people with disabilities, allowing them to lead more active and independent lives.
- A state Complete Streets policy will give local governments more flexibility to build roads that meet the needs in their community.
- Complete Streets promotes public health by supporting exercise as a part of daily life.
- Complete Streets helps avoid costly future retrofits by making sure that we build roads right the first time.
- Complete Streets supports affordable transportation options for families.
- Complete Streets reduces congestion by providing safe travel choices that encourage non-motorized transportation options, increasing the overall capacity of the transportation network.
- Complete Streets supports more pedestrian, bicycle, and transit travel, which helps protect clean air and clean water and reduces our dependence on costly energy sources.
- Complete Streets promotes economic growth and community stability by providing accessible and efficient connections between home, school, work, recreation, and retail destinations by improving the pedestrian and vehicular environments throughout communities.
- Complete Streets supports vibrant and walkable neighborhoods that improve quality of life and help build community.
