POLICY RECOMMENDER: Engineering.

FISCAL IMPACT: Contract increase in the amount of \$2,754.96. This change order increases the contract amount for the project by \$2,754.96 bringing the revised construction contract to \$1,306,110.47. With this change order the project remains within the authorized project budget and contingencies.

<u>SUMMARY AND ACTION REQUESTED</u>: The City Council is respectfully requested to consider approving Change Order No. 2 for the Inwood Booster Station Improvements project.

LEGISLATIVE HISTORY/BACKGROUND INFORMATION: This change order is being processed at the request of the City for project revisions with a net contract change in an increased amount of \$2,754.96. The change is to accommodate the installation of river rock with landscape fabric (125-feet by 1-foot by 3-inch depth) and steel edging between the proposed retaining wall and split rail fence. The change was requested by Public Works to reduce maintenance associated with turf establishment and weed control.

<u>RECOMMENDATION</u>: Staff is recommending that the City Council approve, *as part of the Consent Agenda*, Change Order No. 2 for the Inwood Booster Station Improvements project. If removed from the consent agenda, the recommended motion for the action is as follows:

"Move to approve Change Order No. 2 for the Inwood Booster Station Improvements thereby increasing the contract amount by \$2,754.96".
