### **BACKGROUND:**

Each year the Planning Staff and the Planning Commission prepare an annual workplan for the Department. The 2017 workplan was reviewed by the Planning Commission in December 2016. The workplan has been simplified from prior years, eliminating completion date goals. The Council typically reviews the work plan and provides comments as needed about Department tasks and priorities. The primary intent of the work plan is to help prioritize the projects the Planning Staff and Planning Commission will be reviewing over the course of 2017, and to also help keep the Commission informed about the internal planning related activities and projects that will be undertaken by the Staff over the coming year. This is a working document that provides guidance to the Commission and Council yet has the flexibility to respond to priorities as they emerge. It will also help the Commission and Planning Staff to gauge its progress at achieving some of its goals for the year.
