I have been an associate professor of ecosystem health at the UMN College of Veterinary Medicine and School of Public Health for the past seven years; we have lived in Lake Elmo for three. My business is understanding and managing health threats at the interface of humans, animals and the environment. I live in Lake Elmo with my wife and three kids and love this area. Thus, I am concerned with the balance between natural resources and development. In addition, from what I can tell there has not been a focus on wildlife (terrestial or aquatic) on this committee to date and I would be interested in that as well. Bottom line, I do this for a living, so I would like to help.

2. What experience and qualifications do you have that demonstrate your ability to support the Purpose and Scope of this Committee?

I have twenty years professional experience as a veterinary public health epidemiologist, conducting research, education activities, service and outreach on ecosystem health. I have been an administrator, teacher/educator and scientist, having managed large projects in North and South America, 15 countries in Africa, and SE Asia. I currently have several research projects in Minnesota surrounding the sustainable use of natural resources in the face of human development. I work with MDNR, MDH, MPCA on issues intersecting industry (livestock agricultlure and extractive) and aquatics, frogs, birds, moose, wolves, deer, among others, and am on several committees at the State level (MDNR and MDH). I also work with a MN tribal community on the sustainability of their natural resources and cultlural practices and values, so have context to add there. These involve issues of ecosystem resilience and sustainability as well as food and water safety and security.

Optimizing the balance between city/county/state development goals (population size and land use) with preservation/conservation of traditional local culture and natural resource health and sustainability.
