WHEREAS, Leonard Hanson
has applied for a Conditional Use Permit for an Open Sales Lot
on The South 627.9 ft. of the W 618.0 ft of all that part of the
SE 1/4 of the SE 1/4 of Sec. 35 T29N, R21W, East Oakdale Twnship
lying N of the Northerly right-of-way of Mn. Highway 12.
at 10824 Hudson Blvd.
in the City of Lake Elmo from January 1, 1983 through December 31,
198 <u>3</u> ; and has submitted all required information and fees for the
application for such permit; and,
WHEREAS, Section 301.070 D. 1. b. (5) of the
Municipal Code of Lake Elmo requires a Conditional Use Permit to
operate an <u>Open Sales Lot</u>
in the City of Lake Elmo; and,
WHEREAS, Sections 301,130 C. D. E. F. G.
of the Municipal Code of Lake Elmo sets forth the conditions under
which said permit may be granted and such use permitted; and,
WHEREAS, the applicant meets or exceeds all the conditions set forth above;
NOW, THEREFORE, BE IT RESOLVED by the City Council of the
City of Lake Elmo,
THAT, the Conditional Use Permit for an Open Sales Lot
is hereby granted to Leonard Hanson
from January 1, 198 <u>3</u> through December 31, 198 <u>3</u> , subject to
the following conditions:
1. There shall be no permanent structures built in support of
this use.
2. The display area for all equipment including the presently
permitted horse trailers shall not exceed and area of 150 by 300' (east-west) in the SE area of the property
3. All other storage of equipment shall be either inside a building

or screened from Hwy. 12 and neighboring properties as

provided by the Zoniig Ordinance.

4. One 4'x 8' non-flashing, illuminated sign shall be permitted.

5. The present ponds shall be kept clean and not be filled.

This Conditional Use Permit may be rescinded, after a 2 week notice and a public hearing, if the City Council finds that the public health, safety, or welfare is jeopordized.
