WHEREAS, the applicant meets or exceeds all the conditions set forth above;
NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lake Elmo,
THAT, the Conditional Use Permit for a dog kennel
at 8415 38th St. N.
is hereby granted to <u>Geraldine Breheim</u>
from January 1, 198 3 through December 31, 198 3 , subject to
the following conditions:
1. There shall be no more than 7 dogs over the age of 6 months in the kennel at any time.
<ol> <li>The use is not transferable.</li> <li>The kennel shall be set back 400 ft. from existing property owners.</li> </ol>
4. The dogs shall be enclosed in runs.

This Conditional Use Permit may be rescinded, after a 2 week notice and a public hearing, if the City Council finds that the public health, safety, or welfare is jeopordized.
