NOW, THEREFORE, BE IT RESOLVED by the City Council of the
City of Lake Elmo,
THAT, the Conditional Use Permit <u>for an Open Sales Lot</u>
at 11260 Hudson Blvd.
is hereby granted to <u>St. Croix Riverman Drum &amp; Bugle Corp.</u> From January 1, 198 <u>3</u> through December 31, 1983 , subject to
the following conditions:
a. The flea market operation shall be for the same season as
the drive-in theater, that is, March through October of each year.
1. mile Cite to the term of the control of the cont

- b. The flea market operation shall be on Sundays only and the hours of operation shall be from 9 a.m. to 4 p.m.
- The only sign for the flea market operation shall be on the theater marquee. c.
- The City reserves the right to require a licensed police

officer if a safety problem develops at the flea market operation.

- e. The City shall be advised by the applicant in the event more than one hundred vendor spaces are rented.
- f. This permit shall be valid only through December 31, 1983 and can be denied or revoked if these conditions are violated.

This Conditional Use Permit may be rescinded, after a 2 week notice and a public hearing, if the City Council finds that the public health, safety, or welfare is jeapordized.
