from January 1, 1983 through December 31, 1983 , subject to
the following conditions:
1. There shall be no more than 117 dogs in the kennel at any time. 2. The owner shall maintain a Perpetual Trust Fund for care of the
pet cemetary.
3. The owners may operate an Obedience Training School at this location 4. The owners shall maintain parking facilities for 100 cars.

This Conditional Use Permit may be rescinded, after a 2 week notice and a public hearing, if the City Council finds that the public health, safety, or welfare is jeopordized.
