A RESOLUTION GRANTING A CONDITIONAL USE PERMIT
TO Ellen F. Pinnell
FOR a Private Dog Kennel
IN THE RR ZONING DISTRICT FROM JANUARY 1, 1983 through
DECEMBER 31, 1983.

WHEREAS, Ellen E. Pinnell
has applied for a Conditional Use Permit for a private dog kennel
on 10 A Pt NE 1/4 of SW 1/4 Bcg at cen of Sb Sec 12 the due S
along E line Retain roadway Township 29, Range 21

at 11514 Stillwater Blvd. N.
in the City of Lake Elmo from January 1, 1983 through December 31,
1983; and has submitted all required information and fees for the
application for such permit; and,

WHEREAS, Section 301.070 D. 2. a. (3) of the
Municipal Code of Lake Elmo requires a Conditional Use Permit to
operate a private dog kennel
in the City of Lake Elmo; and,

WHEREAS, Sections 1402
of the Municipal Code of Lake Elmo sets forth the conditions under
which said permit may be granted and such use permitted; and,

WHEREAS, the applicant meets or exceeds all the conditions
set forth above;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the
City of Lake Elmo,

THAT, the Conditional Use Permit for a private dog kennel
at 11514 Stillwater Blvd. N.

is hereby granted to Ellen E. Pinnell
from January 1, 1983 through December 31, 1983, subject to
the following conditions:

1. There shall be no more than 10 dogs in the kennel at any time.
2. The dogs shall be housed in the barn and not permitted to run loose.

This Conditional Use Permit may be rescinded, after a 2 week notice and a public hearing, if the City Council finds that the public health, safety, or welfare is jeopardized.
