ISSUE BEFORE COUNCIL:

City Council is asked to review and accept, as part of Consent Agenda, a brief description of activities that have taken place in the Public Works Department in the month of July 2021.

PROPOSAL DETAILS/ANALYSIS:

STREETS

- Continue pot hole repair
- The Heritage Farms, Old Village, Hamlet on Sunfish and 38th/39th street/utility projects continue
- 2021 crack sealing of many city trails and select streets were completed
- The city radar trailer has been moved around the city this month to include 39th St
- Set up barricades, extra garbage cans and participated in National
- GIS intern completed gpsing all city street signs and creating a digital map
- Staff continue setting up devices to take annual traffic counts
- Completed 1st round of Ditch mowing
- Set up Radar Trailer on 5th st and 39th for a week each

WATER

- Complete monthly MDH bacteria, fluoride, Lead/copper sampling and submit well water draw down reports
- Water usage is averaging 2.1 million per day. Wells are averaging 12-13 hrs per day. The implementation of the new irrigation hours has kept water demand down during peak hours and the city's water system in check
- A dozen water restriction signs were installed at the entrances of developments with the highest violations, including Inwood, Savona, LakesRidge Crossing and Boulder Ponds
- Staff continue irrigation violation enforcement one to two days a week. Staff are finding around a dozen violators each time we go out to enforce in the early mornings
- Begin updating our emergency response plan for the water system
- Correct meter reading issues
- Rebuilt and maintained two Pressure Reducing valves. Added pressure gauges on the PRV located at the raidroad tracks on Lake Elmo Ave. All PRV's will be on a regular maintenance schedule going forward.

SEWER

- Completed annual lift station pump inspections. Issues found are being addressed SURFACE WATER
 - Begin 2021 MS4 inspections

PARKS

- Completed mowing all city trail edges
- Created new intersection maps for the Sunfish Lake Park Trails. The signs are being produced and are expected to be install by August 20th.
- The two new bike paths have been completed in Sunfish Lake Park. The trails will minimize contact and complaints between the users.
- Complete monthly playground inspections

FACILITIES

• Rebuilt the failing Fire Hall 2 retaining walls

SAFETY COMMITTIEE

• Completed quarterly safety inspections of Fire Department. Review all department safety concerns and any incident/accidents
