ISSUE BEFORE COUNCIL: Should the City Council accept the improvements and approve Pay Request No. 1 (FINAL) for the 2021 Seal Coat Project?

BACKGROUND: The 2021 Seal Coat Project has been fully completed. The Project Engineer has prepared a Certificate of Completion and is recommending acceptance of the improvements and release of payment in full. The one-year warranty period will begin on December 7, 2021, and will extend to December 7, 2022.

PROPOSAL DETAILS/ANALYSIS: Asphalt Surface Technologies has submitted Pay Request No. 1 (FINAL) in the amount of \$78,438.00. The request has been reviewed and payment is recommended in the amount requested.

<u>FISCAL IMPACT</u>: None. Payment is proposed in accordance with the contract for the project. The project has been completed within the authorized scope and budget.
