# **BACKGROUND:**

At the November 3, 2021 meeting, Council awarded bids for the new city center and public works addition. Also established at that time was Guaranteed Maximum Price (GMP) with H+U for construction costs. The GMP was \$13,402,788.

At the July 5, 2022 meeting, the city council approved change orders for the motor power clarifications (\$109,862) and public works revisions (\$122,789). That approval did not include increasing the GMP for H+U at th time as it was unknown which contingency would be needed to cover these costs.

# **ISSUE BEFORE COUNCIL:**

Should Council approve Change Order #3 for the City Center Public Works Addition Project and increase H+U's GMP by \$232,651?

### **PROPOSAL:**

A copy of the proposed change order is included in your packet. This change order doesn't increase the project costs but rather allocates additional resources in the budget from city contingency to H+U's GMP for increases the council already approved in July 2022.

## **FISCAL IMPACT:**

With this pay request, the project remains within the overall budget of \$15,727,941 by reducing the city's contingency and increasing H+U's GMP by an equal amount.
