ISSUE BEFORE COUNCIL: The City Council is respectfully requested to hold a Public Hearing for the proposed assessments for the 2024 Street and Utility Improvements. Following the hearing, should the City Council adopt the final assessment roll?

BACKGROUND: On September 17, 2024, the City Council approved a Resolution declaring the costs to be assessed, ordering the preparation of the proposed assessment, and calling for the hearing on proposed assessment for the 2024 Street and Utility Improvements. Mailed notice has been provided to each assessed property and notice of the public hearing has been published in the local paper.

PROPOSAL DETAILS/ANALYSIS: Pursuant to Minnesota Statutes, Section 429, the Council must declare the amount to be assessed against the benefitting properties and the Hearing on the proposed Assessment for these Improvements must be held. Staff has enclosed a proposed Final Assessment Roll which has been calculated in accordance with the approved Feasibility Report and the City's Special Assessment Policy.

A portion of the project is proposed to be assessed to the benefitting properties. Based on the anticipated final project costs, the street and drainage per linear foot and residential unit assessments for the Carriage Station Addition can be lowered from \$155/LF to \$110/LF, and from \$6,000 per residential property to \$4,200. The street and drainage unit assessment for the Fredrich Heights Addition (Jamaca Court N) can be lowered from \$8,500 per residential property to \$8,100. Assessments for street and drainage improvements will be levied over a 15-year period and charged an interest rate of 5.5%.

At the preliminary assessment hearing on November 21, 2024, it was noted that Carriage Station Park was listed as Carriage Station HOA owned even though the Park has been operated and maintained as a City Park. Therefore, the 3-unit Park assessments were assigned to the Carriage Station HOA. In preparation for the final assessment hearing it has been determined that the deed transfer of the Park to the City remains incomplete, therefore the final assessment hearing continues to assign the Park assessment to the Carriage Station HOA. Once the deed has been executed and transferred to the City, the assignment of the assessment can be revised. It is advisable to that the fully executed transfer get completed prior to Certification of the Assessment to the County on November 15, 2024.

FISCAL IMPACT: Attached to this agenda report is a summary of the Estimate to Completion Total Project Costs showing the cost breakdown by infrastructure component and resulting unit assessment. The estimated total project cost at completion is \$2,418,000; including \$2,000,000 for the street and drainage improvements and \$418,000 for the water system improvements. Of these costs, \$626,000 will be specially

assessed, \$418,000 will be funded through the Water Enterprise Fund, and the remaining costs will be funded through the project bond proceeds and general tax levy.

RECOMMENDATION: Staff is recommending that the City Council approve a resolution adopting the Final Assessment Roll for the 2024 Street and Utility Improvements. The recommended motion for this action is as follows:

"Move to approve Resolution No. 2024-112, Adopting the Final Assessment Roll for the 2024 Street and Utility Improvements."

RESOLUTION NO. 2024-112 A RESOLUTION ADOPTING THE FINAL ASSESSMENT ROLL FOR THE 2024 STREET AND UTILITY IMPROVEMENTS

WHEREAS, pursuant to proper notice duly given as required by law, the Council has met and heard and passed upon all objections to the proposed assessment for the 2024 Street and Utility Improvements including street, drainage, and water system improvements.

NOW, THEREFORE, BE IT RESOLVED,

CITY OF LAKE ELMO

- 1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of land therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2. Such assessment shall be payable in equal annual installments extending over 15 years for street and drainage improvements, the first of the installments to be payable on or before the first Monday in January, 2025 and shall bear interest at the rate of 5.5 percent per annum from the adoption date of this assessment resolution. To the first installment shall be added interest on the entire assessment from the date of this resolution until December 31, 2024. To each subsequent installment, when due, shall be added interest for one year on all unpaid installments.
- 3. The owner of any property so assessed may, at any time prior to the certification of the assessment to the county auditor, pay the whole of the assessment on such property, with the interest accrued to the date of payment, to the City Clerk, except that no interest shall be charged if the entire assessment is paid within 30 days from the adoption of this resolution; and he/she may, at any time thereafter, pay to the City Clerk the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the next succeeding year.
- 4. The City Clerk shall forthwith transmit a certified duplicate of this assessment to the County Auditor to be extended on the property tax lists of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.

CITY OF LAKE ELMO NOTICE OF HEARING ON PROPOSED ASSESSMENT 2024 STREET AND UTILITY IMPROVEMENTS

Notice is hereby given that the City Council of Lake Elmo will conduct a public hearing on **Tuesday October 15, 2024** at, or approximately after, 7:00 P.M. at Lake Elmo City Hall to consider, and possibly adopt, the proposed assessment against abutting properties for the 2024 Street and Utility Improvements. Adoption by the Council of the proposed assessment may occur at the hearing. The following describes the proposed improvements and area(s) to be assessed:

Street and drainage improvements along the public streets within the Carriage Station Addition and the Fredrich Heights Addition, including the reclamation of the street with new bituminous pavement, spot replacement of concrete curb and gutter in Carriage Station subdivision, and new ribbon concrete curb and gutter along Jamaca Court. As part of the street improvements the project incorporated partial storm sewer repair and restoration of the existing street drainage system. The project includes approximately 8,500 feet (1.6 miles) of public streets including the following segments:

Carriage Station

- Marquess Trail North, from CSAH 15 to 55th Street North.
- Marquess Lane North, from Marquess Trail North to Marquess Trail North.
- Marquess Way North, from Marquess Trail North to Marquess Trail North.
- Marquess Trail Circle North, from Marquess Trail North to north end cul-de-sac.
- Marquess Trail Court North, from Marquess Trail North to south end cul-de-sac.
- Marquess Lane Cove North, from Marquess Lane North to south end cul-de-sac.

Friedrich Heights (Jamaca Court N)

• Jamaca Court North from Jamaca Avenue North to the cul-de-sac.

You may at any time prior to certification of the assessment to the county auditor on November 15, 2024, pay the entire assessment on such property to the City Clerk with interest accrued to the date of payment. No interest shall be charged if the entire assessment is paid to the City Clerk prior to November 1, 2024. You may at any time thereafter, pay to the City Clerk the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 (for the assessment to be certified to County Auditor) or interest will be charged through December 31 of the succeeding year. If you decide not to prepay the assessment before the date given above the rate of interest that will apply is 5.5 percent per year.

Once assessments are certified to the County, the assessments are payable in equal annual installments extending over a period of 15 years for street and drainage improvements, the first of the installments to be payable on or before the first Monday in January 2025 and will bear interest at the rate of 5.5 percent per annum from the date of adoption of the assessment resolution. To the first installment shall be added interest on the entire assessment from the date of the assessment resolution until December 31, 2024. To each subsequent installment when due shall be added interest for one year on all unpaid installments.

The proposed assessment roll is on file for public inspection at the City Clerk's office. The total street improvement amount to be assessed is \$626,000. The City contribution for the overall improvement project is \$1,792,000. Written or oral objections will be considered at the meeting.

No appeal may be taken as to the amount of an assessment unless a written objection signed by the affected property owner is filed with the municipal clerk prior to the assessment hearing or presented to the presiding officer at the hearing. The Council may upon such notice consider any objection to the amount of a proposed individual assessment at an adjourned meeting upon such further notice to the affected property owners as it deems advisable.

An owner may appeal an assessment to district court pursuant to Minnesota Statutes, Section 429.081 by serving notice of the appeal upon the Mayor or Clerk within 30 days after the adoption of the assessment and filing such notice with the district court within ten days after service upon the Mayor or Clerk.

The City Council is authorized in its discretion to defer the payment of an assessment for any homestead property owned by a person for whom it would be a hardship to make payment if the owner is 65 years of age or older and/or the owner is a person retired by virtue of a permanent and total disability or by a person who is a member of the Minnesota National Guard or other military reserves who is ordered into active military service, as defined in section 190.05 subdivision 5b or 5c, as stated in the person's military orders, for whom it would be a hardship to make the payments. The owner must request a deferment of the assessment at or before the public hearing at which the assessment is adopted and make application on forms prescribed by the City Clerk within 30 days after the adoption.

Notwithstanding the standards and guidelines established by the City for determining a hardship, a deferment of an assessment may be obtained pursuant to Minnesota Statutes Section 435.193.
