The city has received a donation of \$1,650 from Bob and Holly Kress, to be used for community improvement within Sunfish Lake Park. The Kress's reached out to city staff requesting to place a park bench in Sunfish Lake Park near the lake.

PROPOSAL DETAILS/ANALYSIS:

Bob and Holly Kress wish to make a donation of \$1,650 toward a park improvement in Sunfish Lake Park. The donation would help purchase a bench to be placed along the trail system within the park. Included in your packet is a resolution for the Council to officially accept the donation.

The Parks Commission made a motion at its April 21st meeting to recommend to the City Council to approve the donation from Bob and Holly Kress and purchase a bench, placard and installation materials not to exceed \$1,650 to be placed in Sunfish Lake Park.
