WHEREAS, the City of Lake Elmo has adopted the following described
Resolution relating to the issuance of a Conditional Use Permit for
the St. Croix Riverman Drum and Bugle Corp.:

27, 1983 as Document No. 444347; and

situated in Washington County, Minnesota to wit:

described real property situated in Washington County, Minnesota to
wit:

The Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 36,
Township 29, Range 21 except the South 219.5 feet of the
East 847.7 feet thereof; and


WHEREAS, the purpose of this Resolution is to correct the error

East 847.7 feet thereof.


AND, BE IT FURTHER RESOLVED that a copy of this correcting
