BE IT RESOLVED BY THE CITY COUNCIL OF LAKE ELMO, MINNESOTA


1. A certain petition requesting the improvement of 50th Street between State Highway 5 and County Road 17 (Lake Elmo Avenue), filed with the Council on June 20, 2000, is hereby declared to be signed by the required percentage of owners of property affected thereby. This declaration is made in conformity to Minnesota Statutes 429.035.
2. The petition is hereby referred to the City Engineer and he is instructed to report to the Council with all convenient speed advising the Council in a preliminary way as to whether it should best be made as proposed or in connection with some other improvement, and the estimated cost of the improvement as recommended.
3. The Council directed the City Engineer to study traffic calming devices, back-to-back cul-de-sacs, and a bike path connecting to the Stillwater High School.
