

ORDINANCE 97-136

AN ORDINANCE AMENDING SECTION 300.07 "ZONING DISTRICT MAP" OF THE
LAKE ELMO MUNICIPAL CODE

Section 1. Amendment: Section 300.07, Subd. 3 A.1. of the "Zoning District Map" of the Lake Elmo Municipal Code; is amended to rezone property from Rural Residential (RR) to Single Family Residential (R-1) based on conformity with the Comprehensive Plan, owned by Daniel and Jean Olinger, 9057 Lake Jane Trail, legally described as follows:

That part of the Government Lot 5 of Section 10, Township 29 North, Range 21 West, Washington County, Minnesota, described as follows:


Section 2. Effective Date: This ordinance shall become effective upon passage and publication according to law.
