SUB-DIVISION - Roads:

Due to the high cost of the base preparation blacktopping specified in the present ordinance and the fact that this has to be torn up to add water and sewer facilities, it is recommended that we amend the sub-division ordinance to allow suitable ciling of the roads in place of blacktopping now specified. This would apply only where sewer and water is not being installed and would only apply to minor or residential streets. All other specifications in preference to the ordinance must be met.

All of the regulations concerning construction of the roads would apply with the exception that where suitable sub-base is found on the line of improvement. Where existing soil structure meets specifications, it may be approved by town engineer.

ORDINANCE #14, SECTION 20:(township ordinances)

With reference to Ordinance #14, Section 20, involving parcels of land over five (5) acres which are exceptions from the sub-division ordinance, that a plan be presented of plats of this size showing possible later division into specified sized lots for purpose of location of buildings to be constructed enabling later division in a manner consistent with our present sub-division regulations.

Report submitted by Klehn on oil as surface treatment-residential streets.
