- 1. Advise owners to use a line 100ft. east of section line as a future county road right of way.
- 2. Determine building setback from that line. Jack Evert second -- carried 5 aye.

Hearing on special use permit for Jim Trudeau Dog Kennels--Written notice sent to all adjoining landowners. Jack Evert moved that based on results of hearing, (no adjacent landowners attended) the Planning Commission recommends granting a special use permit to Jir Trudeau, to operate a dog kennel subject to following conditions:

- 1. Time limits on degs being out (8:00 to 9:00 only).
- 2. Owner-operator shall take steps to abate noise or any other nuisance.

3. Permit shall be reviewed once each year.

- 4. Premises shall be maintained in a safe, clean, sanitary manner.
- 5. Sanitary disposal system shall be approved by engineer and subject to periodic inspection.

6. Pleasing view shall be maintained (no junk, weeds,

ill-repair, etc.)

- 7. If nuisances (noise, debris, safety hazards, etc.) occur the permit may be revoked or amended following a public hearing.
- 8. Permit ceases upon land acquisition by Metro Park
