LAKE ELMO PLANNING COMMISSION MINUTES

JULY 25, 1988 -- 7:30 p.m.

WORK SESSION

Present: DeLapp, Hunt, Enes, Johnston, Kunde. Absent: Bucheck, Williams, Johnson, Stevens, Haacke, Simpson.

Comprehensive Plan: The workshop was scheduled to review the Comp Plan; however, as M. Williams was not present, other matters were discussed. It was determined and reaffirmed by Lee Hunt that he would pursue the capability of creating a disc containing the draft Comp. Plan for use on the City's Apple computer.

Proposed RE Ordinance: Lee Hunt reviewed the progress of the proposed RE Ordinance as being discussed by the Council/Planning Commission subcommittee. He advised the next committee meeting would be held on August 4th at 11:30 a.m.

He advised roadway and landscaping provisions had been discussed and that it appeared that private roadways were being discouraged. He also expressed concern that the proposed ordinance may be losing some of its original intent, and that it maybe becoming an expanded R-1 zoning district.

Morton/Engstrom Development: Planning Commission members discussed the forthcoming proposal from Morton/Engstrom for development of a 50 acre parcel, into 18 lots, off County Rd. 17. The consensus:

1.) Should be a 24' wide public roadway, with removal only of shrubs/trees, in the right of way, of less than 5" diameter; 2.) curb along roadway should be gently tapered to allow off-access for bikers; 3.) roadway should be a long, meandering road with a cul-de-sac large enough to allow for turnaround of emergency fire equipment; 4.) minimum acreage shall be 2 1/2 acre lots with allowance for variance in frontage requirements; and, 5.) no front entry signs shall be allowed.

Adjourn : The work session was adjourned at approximately 9:30 p.m.
