Mayor Pro-Tem Gaasch called the Regular City Council meeting to order at 7:30 p.m.

Councilors present: Mary Gaasch, Roxanne Grove, Denise Hawkinson, and Lara Mac Lean.

Councilors absent: Mayor Jeff Dains.

Staff present: Heather Butkowski, City Administrator; Jim Bownik, Assistant City Administrator; and Terry Berg, Deputy City Clerk.

Approvals

Mayor Pro-Tem Gaasch asked for changes to the meeting agenda. Motion was made by Councilor Grove to add the Closed Session for 1828 Eustis Street to the agenda, seconded by Councilor Mac Lean and carried unanimously.

Councilor Grove moved to approve the City Council meeting minutes of April 28, 2015. Councilor Hawkinson seconded the motion and carried unanimously.

Councilor Mac Lean moved and seconded by Councilor Grove to approve the claims totaling \$92,069.05. Motion carried unanimously.

Consent

Mayor Pro-Tem Gaasch asked if any Councilors wished to remove items from the Consent Agenda. There being none, Councilor Mac Lean moved and seconded by Councilor Grove to approve the Consent Agenda acknowledging the March Financial Report. Motion carried unanimously.

Informational Presentations

A. Garage Sale Report

Assistant City Administrator Bownik reported the city-wide garage sale is Saturday, May 16 beginning at 8:00 a.m. The City is promoting the event at no charge with 22 registrants. Advertisement includes Craig's List, City website, Facebook, mailed copies to participants, email to the City distribution list, and copies available at City Hall.

Discussion / Action Items

Mayor Pro-Tem Gaasch adjusted the agenda allowing time for police officers to arrive for the resolution.

B. Larpenteur Avenue Project – Electrical Service Quote and Pay Request No. 2 City Administrator Butkowski summarized the report from the city engineer that the original construction plans assumed electrical service would be provided by Xcel Energy instead the City must bring the connection to the nearest light pole. The change order to complete this work is \$5,350.00, bringing the contract to \$318,421.00, which is slightly over budget.

Pay Request No 2 in the amount of \$42,867.80 was presented for approval.

Motion was made by Councilor Hawkinson and seconded by Council Mac Lean to approve Change Order No 1 and Pay Request No 2. Motion carried unanimously on a roll call vote.

C. Inflow and Infiltration Monitor Plan

City Administrator Butkowski reviewed the engineer's scope of work to install five sewer flow meters in various locations throughout the City to identify inflow and infiltration problems. The scope of work is estimated at \$29,000 and will depend on the rainfall received. Administrator Butkowski noted the City has an obligation of \$50,000 to investigate inflow and infiltration in 2015.

Moved by Councilor Mac Lean and seconded by Councilor Hawkinson to approve the Inflow and Infiltration Sanitary Flow Monitoring Proposal as presented. Motion carried unanimously on a roll call vote.

A. Resolution 051215A – National Peace Officers' Week

Mayor Pro-Tem Gaasch introduced the resolution recognizing National Peace Officers' Week and expressed appreciation on behalf of the City for the quality police service and relationship with residents from the St. Anthony Police Department.

Councilor Hawkinson read the resolution in its entirety. Motion was made by Councilor Grove and seconded by Councilor Mac Lean to adopt Resolution 051215A – Proclaiming Police Week. Motion carried unanimously on a roll call vote.

Sergeant Mangseth was in attendance and addressed the council.

Mayor Pro-Tem Gaasch called for a recess at 7:50 p.m. with the meeting resuming at 8:05 p.m.

City Administrator noted the next meeting may include the April Financial Report, Recycling Grant Update, Quarterly Investment Report, Public Works Maintenance Staff Appointment, and Tennis and Basketball Court Maintenance Recommendations.

A. Public Comment

Ashley Peterson of 1851 Carl Street addressed the Council regarding her violation of City Code by having three adult dogs where the code states two. Ms. Peterson has one dog and her roommate, Kristina Schwartz, has two with all dogs' current on vaccinations and kept in a fenced backyard. One neighbor has objected to the additional dog. Mayor Pro-Tem Gaasch responded that the City has recently updated the City Code and did not provide a mechanism to allow more than two like animals on a property. In summary, the City Council will review the ordinance with City Administrator Butkowski stating the deadline of May 20 is suspended until the full Council can review.

B. Public Works Wage Scale

Administrator Butkowski reviewed the information compiled by staff with Council consensus that Lauderdale's pay scale is in-line with no change recommended.

C. Larpenteur Avenue Light Pole Banners

Previously, it had been discussed to add banners to decorative light poles on Larpenteur Avenue. Following discussion Councilor Hawkinson will work with staff on researching banner options and costs.

D. Community Development Update

Councilor Mac Lean inquired as to the sale status of the Chinese Christian Church with staff responding that the church representatives have not determined a price. A private developer is also interested in the property due to the 14 underlying lots.

Administrator Butkowski updated Council on the seminary property and possible expansion to include a fitness center.

Mayor Pro-Tem Gaasch called a closed session at 8:30 p.m. for the purpose of real estate negotiation per Minnesota Statutes 13D.05.

The Council returned from the closed session at 8:58 p.m.

Memorandum RE: Project Wrap Up

The Cities of Lauderdale and Falcon Heights identified a need for more efficient and effective ways for residents to dispose of bulky items such as mattresses, furniture and appliances. There are available options, but they are inconvenient, costly and difficult for many residents. The result is a growing backlog of unwanted furniture and appliances stored in basements, garages and yards, and, too often, dumped illegally on public or private property.

The Cities of Falcon Heights and Lauderdale, utilizing a grant from Ramsey County, conducted a Single Unit Residential Bulky Waste Collection Pilot Project in 2012 – 2013. Bulky wastes for this project included furniture, appliances, electronic goods, lawn mowers/snow blowers, and similar materials.

The City retained the consultant, Foth Infrastructure & Environment, LLC (Foth) to assist with research and project implementation. Foth documented the results of the pilot project in a report *Bulky Waste Pilot Collection Program* (January 2014). The project was successful in assisting residents to properly recycle/dispose of bulky wastes, and the City Councils wished to further explore bulky waste issues for possible long-term programs. Before developing a comprehensive program, both Cities determined that an evaluation of the bulky waste issues faced by multiunit residential properties was needed.

A second Public Entity Innovation Grant (PEIG) was obtained by the Cities from Ramsey County to evaluate multiunit residential bulky waste issues in two phases. The first phase objective was to interview managers of multiunit residential properties (MRPs) to determine the breadth and specifics of bulky waste issues. The second phase objective, if needed, was to conduct a pilot project for multiunit bulky waste management congruent to the single family pilot conducted previously.

Phase One Accomplishments

The Project Team consisted of:

- ♦ Jim Bownik with the City of Lauderdale
- ♦ Chelsea Petersen with the City of Falcon Heights
- ♦ Jean Buckley with Ramsey County
- ♦ Susan Young, with Foth

The Project Team developed a set of interview questions to obtain information from multi-unit property owners about bulky wastes management issues. Interviews were conducted by Foth and the project team met to discuss the results of the interviews and determine next steps. Interviews with managers or owners of seven (7) properties were conducted in November and December of 2014. A Letter Report to the Cities was finalized in March, 2015.

Project Budget and Spending Status

The Project Budget (Attachment 1) was broken into two parts:

Phase 2a: Assessment, and Phase 2b: Pilot Study.

The Phase 2a: Assessment budget was \$14,750; monies spent were \$14,742.

The Phase 2b: Pilot Study budget was \$45,250; monies spent was \$0.

Timeline

The timeline proposed in the application was:

- ♦ August-September, 2014 Design surveys, compile list of landlords to be contacted.
- ◆ September—October, 2014 Conduct interviews of landlords and survey tenants, taking advantage of fresh impressions of "Move out move in weekend" August 30- September 1.
- ♦ October, 2014 Evaluate interview and survey results, determine feasibility of pilot collection event.
- ♦ November–December, 2014 Report Phase 2a.

A meeting was held by the Project Team on August 5, 2014 to discuss the approach for the project, although it was agreed that work could not progress until the Grant was received and executed by the County and the Cities. The final executed PEIG grant from Ramsey was received October 20, 2014 by the City of Falcon Heights and the Kickoff Meeting for the Project was held on October 27.

The interview questions and the target multi-unit properties were approved in early November. Interviews were conducted in November and December, as properties were willing to be interviewed. Batches of interview reports were sent to the Project Team in December. The draft Summary Report was sent to the Project Team January 23. Comments were received and addressed, and the final Summary Report was delivered February 24, 2015.

Barriers Encountered and Solutions Implemented

As noted in the report, multiunit property owners/managers are difficult to contact and somewhat reluctant to speak about potential problems at their properties. Many follow-up calls and site visits were made to properties, and a determination that a representative sample of property types was sufficient to fulfill the goals of the project was made.

Lessons Learned

As stated in the Summary Report, the lessons learned included:

- 1. Illegal dumping of bulky waste depends on the facility location. Properties directly on main roads (e.g. Larpenteur) with convenient access to the dumpster area reported more illegal dumping by non-residents than properties located on side streets, or which require several turns to get to the dumpster areas.
- 2. There is no particular month or time of year that all MRPs have units turn over. The type of resident that the MRP attracts determines the schedule and frequency of bulky goods/bulky waste generation.
- 3. Property managers have many duties, often manage several properties, and are difficult to contact and speak with. Trash and recycling are not high priorities compared to overflowing toilets, showing units to potential renters, dealing with late rent payments or keeping up with basic maintenance.
- 4. As long as waste "goes away" it is not a problem to building managers or occupants. Solid waste and recycling is seldom managed as a discrete cost center capable of reduction or improved efficiency.
- 5. Information to highlight resource and cost savings by reducing waste amounts could be provided to MRP managers. Managers could then determine if tasking an individual to manage the waste streams for greatest efficiency is cost-effective for that property.
- 6. Sending information about waste costs or recycling information to the managers by mail or email was stated by managers to be more effective than phone calls or putting information in tenant mail boxes. Managers specifically requested that the mailings come to them, in their name, and that the information should not look like "junk mail." Most managers were very open to including printed information about recycling and bulky waste options from the cities in the move-in packets.
- 7. Language and culture can be barriers to tenant recycling. Recycling can be a new concept, especially in those MRPs that cater to university or exchange students. Information that explains the basic "what, why, and how" of recycling would be helpful. Information in languages other than English would also be helpful; one manager specifically requested information in Chinese. Posters or stick-on signs for the dumpsters that are picture-based (instead of using words) would also be helpful.
- 8. A specific event or single-time bulky waste collection was not identified by managers of MRPs to be helpful in bulky waste management, because of the variability of bulky waste generation. Several managers stated that a program in which they could use pre-paid "vouchers" to take material to a transfer station would be very helpful. If the two cities were to begin such an effort for single unit residents, as was discussed in the previous PEIG grant program, MRPs could be included in the program.

9. "Next steps" for the Cities to pursue in bulky waste management could include evaluation of voucher programs to dispose of bulky wastes for single unit residential properties and MRPs. Provision of education materials targeted to MRP residents would also be a valued next step, customized for multicultural and transient audiences. Foth does not recommend a pilot program specifically for MRP because the managers interviewed do not believe such a program would be helpful and due to the diversity of bulky waste management needs and practices at multiunit properties.

Progress Towards Meeting Project Goals

The Goals of Phase One (Single unit homes) and Phase Two (multiunit homes) were to determine the extent of bulky waste problems in the two cities and to pilot alternatives for identified problems. Phase One identified issues of collection and costs to residents, and a pilot program to test a possible resolution was conducted. Phase Two determined that multiunit homes do not have a significant bulky waste issue that could be improved with City intervention, so the Cities determined that a pilot program is not appropriate.

Next Steps

The results of the Phase Two work will be presented to the City Councils of Falcon Heights and Lauderdale by city staff in May/June. The Cities will also consider improving educational material targeting multicultural and transient MRP residents.

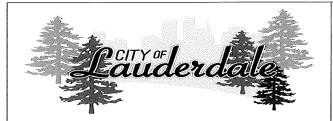

Fiscal Policy

The City of Lauderdale requires that all expenditures be valid based upon the public purpose for which it is purchased and the specific or implied authority for the expenditure found in Minnesota State Statutes and as authorized as part of the City of Lauderdale's annual budget.

Employee and Volunteer Recognition Program

Purpose

The City Council recognizes the hard work and service performed by the employees and volunteers of the City of Lauderdale and has adopted a formal Employee and Volunteer Recognition Program.

Policy

The City Council believes the benefits of attracting, retaining, and motivating employees through an Employee and Volunteer Recognition Program support job satisfaction, which in turn impacts cooperation and productivity. The result is to provide excellent public and customer service to better serve the interests of the citizens of the community.

Recognition

Certificates are given to employees with 5 years of service and in increments of 5-years thereafter. With the consent of the employee, an article will be published in the city newsletter.

Certificates are given to board/commission members at the end of their appointment or resignation. With the consent of the board or commission member, an article will be published in the city newsletter.

Framed city photograph is given to employees leaving the city with five or more years of service.

A commendation will be presented to the City Council for adoption and a framed city photograph given to the mayor or city councilors upon resignation or the end of their last term.

Commendations may also be presented to municipal employees shared on a contractual basis (police officers and fire fighters). Annually, the City may also provide them coffee, punch and cake/bars/cookies during national police and firefighter recognition weeks.

Program

Mayor, City Council members, and the City Administrator recognize participants. Coffee, punch and cake/bars/cookies are provided for the recognition event.

Food and refreshments are allowed when they are part of a lunch or dinner meeting for official city business when it is the only practical time to meet. These meetings would have a pre-planned agenda and involve meetings with City Council, Board/Commission members, or volunteers.

Food and refreshments may also be offered to volunteers participating in set up and clean up after city events.

Employee Wellness Program

Purpose

The City Council's mission is to enhance organizational health by fostering interest in and encouraging employees to initiate or expand healthier lifestyles, and decrease absenteeism due to illness and stress. Minnesota State Statutes 15.46 provides for the city to establish and operate a program of preventive health.

Policy

The City Council believes that organizational health develops a positive culture that is focused on celebrating and improving the quality of life for all employees.

Program

The health insurance program offered by the City provides a Fitness Discount Program that offers a credit toward health club dues in return for working out a required number of times per month.

The City will reimburse employees for any cost to receiving an annual flu shot that is not covered by the employee's health insurance provider.

The City will pay for hepatitis shots for Public Works employees should the employee request, while the shots are not required by OSHA the city believes that the employee's request for wellness is acceptable.

DESCRIPTION OF ISSUE AND PAST COUNCIL ACTION:

As mentioned in the recent Friday Report, Greenway Holdings wants to turn Luther Seminary's old radio station into a fitness center. They have asked city staff what zoning approvals they will needs. That is a complicated question, as such, staff wanted to discuss the matter with the Council before responding back to them.

By way of history, the first Seminary apartments were constructed in the 1960s. Additional housing was built in the 1980s. Apparently, this was done under a planned unit development (PUD) agreement as the City's zoning map has indicated going way back that the property was zoned as a PUD. PUDs allow developers to deviate from City Code, specifically the City's zoning ordinance. Neither the City nor the Seminary was able to find any sort of PUD agreement from the initial construction of housing in the 1960s. As such, all we presumably know is that a PUD was created and the underlying zoning is R-1, single-family residential.

I attached a copy of the City's district uses. As you will see, fitness centers are not a permitted use in the R-1 district (or any district). The owner asked if they could be viewed as a "private club" which is a conditional use in the R-1 district. That would allow them to construct and operate the fitness center if they could show that they meet the City's criteria for a conditional use permit. That likely wouldn't be difficult for them to do.

Alternatively, they could apply for a text amendment to the City's zoning ordinance. The Council would then have to decide whether to add fitness center as a permitted or conditional use in the R-1 district. On the positive side, this would be the most clear way to allow the use as opposed to trying to fit them into an existing classification. On the downside, it opens the possibility for other fitness centers in the R-1 district and generally fitness centers are too commercial to fit in well with single-family residential housing.

Since Ron will be at the meeting, he will be able to help facilitate the discussion. If the Council is opposed to the fitness center concept, staff can let Greenway Holdings know that as well. No matter what, they will need some form of Council approval and wouldn't likely apply for that if the Council seems opposed to the idea of a fitness center at that location.
