DESCRIPTION OF ISSUE AND PAST COUNCIL ACTION:

The canvassing of this year's election returns is on a different schedule than other years so tonight the City Council will convene as the canvassing board. Per Minnesota Statutes section 205.185, the governing body of a city shall act as the canvassing board, canvas the returns, and declare the results of the election within three to ten days after a general election. The write-in candidates for city offices are included in the official canvassing document.

WHEREAS, the City of Lauderdale and Ramsey County election officials have tabulated the votes in Precinct I for Mayor for a term of two years and two Council members for a term of four years effective January 1, 2021.

WHEREAS, the write-in votes also have been tabulated and made a part of this resolution.

NOW THEREFORE, BE IT RESOLVED by the Canvassing Board that Mary Gaasch is duly declared elected to the Office of Mayor for a term of two years beginning January 1, 2021, and that Jeff Dains and Duane Pulford are duly declared elected to the Office of City Council for a term of four years beginning January 1, 2021.

BE IT ALSO RESOLVED, that the City Clerk is directed to certify the election returns to the Ramsey County Auditor.
