Staff representatives of the Middle Mississippi River Watershed Management Organization briefed the City Council on a potential levy that may be implemented. The Organization also discussed potential boundary adjustments that could be made.

8. PUBLIC HEARINGS

A. Issuance of Revenue Bonds to Children's Home Society by the City of Lauderdale under Minnesota State Statutes Sections 469.152 through 469.165.

The Mayor opened the public hearing at 8:15 p.m.

Upon the request of the City Council, the City Administrator read paragraph 12 of the resolution for bond adoption that stated "Nothing in this resolution or in the documents prepared pursuant hereto shall authorize the expenditure of any City funds on the Project or the Bonds other than the revenues derived from the Project. The Bonds do not and shall not constitute an indebtedness, a pecuniary liability, a moral or general obligation or a loan of the credit of the City and the Bonds are not secured by, and are not a charge, lien or encumbrance, legal or equitable, against the City's property, funds, general credit or taxing powers."

The Mayor closed the public hearing at 8:19 p.m.

B. Children's Home Society (1605 Eustis Street): Height Variance.

The Mayor opened the public hearing at 8:19 p.m.

The Zoning Administrator stated that the Children's Home Society had intended to receive a 46-foot height (11-foot variance) and not a 43-foot height when this variance was before the Council in August. Due to the fact that Children's Home now has more complete construction drawings, there is a request for a 47-foot height (12-foot variance).

We are resubmitting our request to exempt the wetland affected by the proposed Children's Home Society project from the Wetland Conservation Act mitigation requirements. We initially made this request in our November 8, 2000 letter to you. The wetland exemption request is supported by the following documents and drawings:

- 1. Combined Project Application (CPA),
- 2. Wetland Delineation Report,
- 3. Boundary and Topographic Survey, and
- 4. Grading, Drainage and Erosion Control Plan (Sheet WET1).

These documents and drawings were submitted in our initial request letter and are not enclosed again in this letter. The wetland exemption request along with a brief discussion of wetland replacement requirements is presented in the remainder of this letter.

Wetland Exemption Request

The existing retention pond contains approximately 3600 square feet of wetland. This retention pond appears to have been built to treat stormwater from the existing Children's Home Society parking area. Both facilities were constructed around 1983. The wetland most likely established in the retention pond under favorable conditions. Approximately 1400 square feet of this wetland will be partially filled in by the construction of the proposed detention pond. The Combined Project Application (CPA), and accompanying wetland delineation report and drawings describe the wetland impacts in detail.

We request that you exempt this wetland from the Wetland Conservation Act (WCA) replacement plan requirements. We feel that the wetland can be exempted under either the incidental wetland (Subd. 5, 103G.2241) or de minimis (Subd. 9, 103G.2241) provisions of the WCA.

Several factors indicate that the wetland was established as an unintentional consequence of constructing the retention pond. This should make the wetland eligible for exemption under the incidental wetland

provisions of the WCA, which is our preferred option to best protect the Children's Home Society's future interests. The wetland delineation report identifies the wetland soils as being excavated or disturbed, and that artificially controlled drainage is the primary hydrology source for this wetland. In addition, aerial photography from 1980 shows that the retention pond and parking area did not exist at that time. However, aerial photography from 1985 shows both the retention pond and parking area, indicating that the retention pond was built to treat the parking area stormwater.

The de minimis provision of the WCA allows up to 2000 square feet of type 2 wetland outside of the shoreland wetland protection zone in the less than 50 percent area to be exempted. The wetland delineation report identifies the wetland as a Circular 39, Type 2. In addition, the report did not identify the wetland in the National Wetland Inventory (NWI) or DNR Protected Waters Inventory (PWI). The proposed project impacts approximately 1400 square feet of the existing wetland. These factors should qualify the proposed wetland impacts for exemption under the de minimis provisions.

As stated in our initial stormwater management plan submittal, the Children's Home Society proposes to construct approximately 2400 square feet of additional wetland in the detention pond as voluntary mitigation. This will bring the total area of wetland on the site to approximately 4600 square feet. In the voluntary mitigation the new wetland area is graded to match the existing elevations of the remaining wetland. The proposed detention pond and outlet are configured to match the existing retention pond shallow ponding and infiltration conditions. The detention pond will create a temporary pool depth of 0.5 to 1.5 feet over the entire wetland area similar to that occurring in the existing retention pond. Stormwater passing through the detention pond will fill this pool and then slowly infiltrate out like that occurring in the existing retention pond. Also, the proposed upland native vegetation cover and the Stormceptor are designed to prevent high levels of pollutants and nutrients from impacting the wetland plants.

In addition, the remaining wetland (approximately 2200 square feet) will be protected from erosion, sedimentation and excessive stormwater runoff during project construction as stated in the stormwater management plan.

Wetland Replacement Requirements

You requested that we provide additional information on the replacement requirements for wetland impacts not exempt from mitigation. The following information is based on our general understanding of this subject, since our office is not an authority on wetland regulatory requirements. If you need detailed information, we encourage you to contact your City Engineer, Mr. Paul Heuer, who office has expertise in this area.

The Wetland Conservation Act (WCA) and Section 404 of the Clean Water Act have different replacement requirements for wetland impacts not exempt from mitigation. The WCA (which is the state law administered by your office) requires that nonexempt impacted wetland areas be replaced with twice the area of equivalent new wetland or a ratio of two to one (2:1). Section 404 (which is the federal

law administered by the Corps of Engineers) requires that nonexempt impacted wetland areas be replaced at a minimum with an equivalent area of new wetland or a ratio of one to one (1:1).

Storm Water Management Plan

In a previous memo (November 9, 2000), we recommended approval of all engineering issues and the Storm Water Management Plan, contingent on lowering the velocity of the water to be discharged into the pond. We now understand that this alteration could cause the water quality structure to not function as desired. Therefore, we withdraw this contingency and recommend approval of the Storm Water Management Plan as submitted.

Wetland

The attached letter from our Wetland Scientist provides detailed information about wetland issues. Following is a brief summary of facts about the existing wetland and the proposed work:

- The existing wetland is located in the bottom of the existing pond.
- Aerial photographs verify that the existing wetland was created in the 1980's when the pond was construction in conjunction with a parking lot expansion. It appears that no wetland existed on the site prior to the parking lot expansion in the 1980's.
- Soil boring indicate that the most of the entire Children's Home Society site has been filled will material.
- The existing wetland has an area of 3600 square feet.
- Proposed filling of the existing wetland is 1400 square feet.
- Proposed creation of new wetland is 2600 square feet. 2400 sq. 44.
- Total area of wetland upon project completion is 4800 square feet.

We recommend that the wetland plan be implemented as proposed, and that the de minimis exemption be approved.

I have reviewed the Local/State/Federal Water Resource CPA Form (CPA Form) for the Childrens Home Society.

Sequencing Analysis

As required by the Wetland Conservation Act alternatives were reviewed that would avoid impacting the wetland. The alternatives are found as a supplement to the CPA form filled out for the project.

Wetland Impact Summary

The existing wetland on-site is 0.08 acres in size and classified as a Type 2. The proposed project will fill 0.03 acres (1400 square feet) to facilitate the construction of an earth berm forming part of the detention pond. The berm is needed to so that storm water flow levels within the detention pond do not back up against the existing Route 280 embankment (required by MNDOT) and that the detention pond has adequate freeboard to control peak storm water flows (requirement by City of Lauderdale).

Recommendation

The Wetland Conservation Act allows 2,000 square feet of fill without replacement under the de minimis exemption. The Federal rules governed by the U.S. Army Corps of Engineers 404 permit may require replacement. The applicant proposes to create an additional 2600 square feet of wetland when constructing the detention pond. This would fulfill the required 1:1 replacement (1400 square feet) of the U.S. Army Corps of Engineer but not meet the required 2:1 (2800 square feet) replacement requirement of the Wetland Conservation Act. It is recommended that the wetland creation be completed as proposed and that the de minimis exemption be requested by the applicant to be in compliance of the Wetland Conservation Act. The exemption can be approved at the staff level or by the Mayor and City Council. If approved a copy of the signed exemption form and the decision should be sent to the Watershed District, Soil and Water Conservation District, Board of Water and Soil Resources, and Department of Natural Resources.

2001 Lauderdale Storm Sewer Rates

BACKGROUND:

In 1994, the City Council adopted a Storm Water Utility Ordinance that created a funding mechanism to help finance future improvements to the storm water system. At that time, the Council approved a \$2.50 per quarter per residential unit fee rate, which was based on research of fees for other cities that have implemented a storm water utility. Fees for other property types were based on this rate using a residential equivalency factor (REF). Acreage and hard surface area for each property type play a part in determining the REF, which attempts to estimate the storm water contribution to the system.

As part of establishing the Utility, the City Council also approved a rate increase each year for four years of at least \$1.00 to the base residential rate. For 1998, 1999, and 2000 the fee was \$6.50 per quarter per residential unit and the equivalent REF increase for other property types. 1998 was the last year of this previously agreed upon rate structure.

I have included the 2001 budget for the Storm Water Improvement Fund to provide a snapshot of current and past finances. As you can see, the fund balance has grown from \$150,114 in year-end 1995 to \$513,404 at projected year-end 2000. This fund balance in conjunction with the \$300,000 DNR matching grant will fund the storm water system upgrades that are part of the street and utility improvement projects in the City.

2001 Lauderdale Sanitary Sewer Rates

BACKGROUND:

2000 BUDGET:

As part of the 2000 budget process, the Council increased sanitary sewer rates approximately 2.63% from \$38.00 to \$39.00 per household per quarter. This increase was intended to offset the increase in sewage charges by the Metropolitan Council Environmental Services (MCES) and the increased costs by the City to operate the lift stations (e.g., maintenance and auto dialer costs).

2001 BUDGET

As stated above, the 2001 Budget represents a stable scenario of sewer charges from MCES. With our current rate scenario, the fund is projecting a \$351 surplus. The 2000 Budget was set up to produce a \$13,187 deficit, but reduced spending will most likely produce a very small surplus. While we increased the rates in 2.63% in 2000 to partly address the 2000 and proposed 2001 shortfall, further increases may be warranted for the purpose of keeping pace with inflation.

Attached is a spreadsheet outlining total expenditures and options for rate increases to generate revenue to cover the costs of the sanitary sewer enterprise fund. The three options that I have presented are summarized below.


