CALL TO ORDER

Chair Winkelaar called the meeting to order.

ROLL CALL

City Council Member Absent: Jeff Dains. Staff Present: Heather Butkowski and Jim Bownik.

APPROVALS

Chair Winkelaar asked if there were any proposed changes to the July 15, 2025 commission meeting agenda or the June 17, 2025 commission meeting minutes. There being none, Carlson made a motion to approve. Davis seconded the motion and it carried unanimously.

INFORMATIONAL PRESENTATIONS / REPORTS

DISCUSSION / ACTION ITEM

A. Day in the Park

Commissioner shared their experiences working the table. The food scrap buckets and seed packets were well received along with the literature. Commissioners polled visitors on their environmental priorities which aligned with the Commissions.

B. DNR Tree Grant Status

Butkowski explained how and why the City applied for the DNR grant to remove and replace boulevard ash trees. So far, nine trees were removed and 10 would be planted the day after the meeting. Cost per tree plus mulch, stakes, and compost totaled around \$400 per tree. Staff is exploring options for more removals and replanting, especially in the nature area.

C. Eureka Tour

The Commission selected a day in August. Staff will verify that day works with Eureka.

D. Arbor Day Foundation Programs

Butkowski explained the tree program offered by the Arbor Day Foundation. They have an online portal for residents to order trees. The minimum order is 200 and the cost is paid for by the City. Tree recipients would plant them. The program can be spread over two seasons (spring and fall). The Commission was interested in the program but 200 is a lot of trees. Staff will check if Falcon Heights would like to partner in the program. Ideally, tree pick up could be combined with Sustainability Fair.

E. Plant Swap

Winkelaar said she would like to organize a plant swap for some time in September. Other members were interested in working with her on the idea.
