#### CALL TO ORDER

Chair Winkelaar called the meeting to order at 7:00 p.m.

#### C. 2026 Goal Setting

Butkowski noted that the commission is about to celebrate its first anniversary. Before year end, the commission needs to renew the terms for Ann Sisel and Bryan Carlson, should they want to stay on the commission. Greg Williams' spot is open. Members asked staff to find out whether Mindy Nakamoto planned to remain on the commission as she has missed most of the meetings. Staff will report back at the next meeting.

Members identified three primary events for next year. Additionally, the members discussed hosting another plant swap in spring and hosting educational events. One idea was to invite people from the insurance industry to present on how climate change is affecting rates and coverage. Staff are discussing options for a joint meeting with the Falcon Heights Commission to partner on a tree give-away event through the Arbor Day Foundation.
