VI. GENERAL POLICY BUSINESS OF THE H.R.A.

A. HRA Resolution 25-05 – Approving the Contract for the Removal of Underground Storage Tanks and Site Cleanup at 3803 Stinson Boulevard (Former Bear Stop Filling Station).

Executive Director Yunker reviewed the bids were received for the Underground Storage Tank System and Fuel Island Canopy Removal at the Former Bear Stop at 3803 Stinson Boulevard. The bids were opened and read aloud. Five bids were received. The bids were checked for mathematical accuracy and tabulated. The low bid was submitted by Rachel Contracting LLC (Rachel) of St. Michael, Minnesota in the amount of \$59,100. Staff recommends the HRA consider these bids and award a contract in the amount of \$59,100 to Rachel based on the results of the bids received. The work should be completed by the end of May.

Commissioner Elnagdy asked what criteria is used when selecting the lowest responsible bid. She noted Rachel Contracting has horrific reviews online. Some of their numbers seem crazy compared to the numbers from the other contractors. She asked if there is a mechanism for re-
