Description	In response to inquiries received from local businesses, the City Council has requested that Planning Commission provide a recommendation regarding the adoption of an ordinance regulating special events in the City. The Planning Commission has invited city businesses to describe the events they would like to host, sponsor or produce.
Background	The City has been approached by three food service related businesses – Stout's Pub, The Coffee Grounds, and Dino's Gyros – inquiring whether these businesses would be allowed to host some variation of tented event, such as a "beer garden", on a limited basis. That is, they are interested in doing this as a one-time or occasional or annual event.
	The city code does not make any provision for this type of event. The city attorney confirms that it is not allowed. Many cities have special event ordinances to allow events under special permits. The City Council has asked the Planning Commission to study the issue and make a recommendation.
	At the July 24 workshop, Commissioners directed staff to invite Falcon Heights businesses to attend a September workshop to communicate their event ideas directly to the Commission. As of September 20, staff received three RSVPs. Follow-up calls have been placed to businesses that had already expressed an interest but not yet responded.

Dear Business Owner

The City of Falcon Heights has been approached by several local businesses interested in holding outdoor events and other special events that are beyond the scope of our current code and, therefore, not permitted in the city at this time. Some examples of these events are

- Serving food and beverages outside a restaurant in a tent in the parking lot as a special promotion on one weekend
- Holding a special outdoor tent sale that does not fit the existing sidewalk sale ordinance
- Using a parking area to hold a community party or cultural event in cooperation with neighborhood and community organizations

The Planning Commission has undertaken a study of special event ordinances and permits in other cities in order to learn how cities manage special events and provide for public health and safety while minimizing extra demands on city resources and disturbance to neighborhoods. In order to determine if adopting such an ordinance is in the best interest of the community and to tailor an ordinance to the specific character of Falcon Heights, the Commission would like to learn more about what local businesses are interested in doing.

If your business has considered hosting a special event that is not allowed now, we would like to invite you or a representative to attend the upcoming Planning Commission workshop at 7:00 p.m. on Tuesday, September 25, to outline your ideas and goals for your event.
