proposed Modification to the Development Program and the proposed Tax Increment Financing Plan on file in the Administrator's Office at City Hall and to make such copies available for inspection by the public.

3. <u>Consultation with Other Taxing Jurisdictions</u>. The Administrator is hereby directed to mail a notice of the public hearing and a copy of the proposed Modification to the Development Program and the proposed Tax Increment Financing Plan to Ramsey County and Independent School District No. 623, informing those taxing jurisdictions of the estimated fiscal and economic impact of the establishment of the proposed tax increment financing district.
