1. Spring Together 2024 Event

Nelson explains Spring Together will be on Saturday, May 18 it avoids the Falcon Elementary PTA night. Staff is wondering about the time of the event. They suggest 3-5 PM to avoid the dinner hour. Commissioners agree to that time. Staff will update the flyer to reflect the new time of the event.

Nelson continues to note that summer programming will have a different look this year. It will be an "open gym" night at Curtiss Field and will not require a registration or a fee to allow everyone the ability to participate. It will be on Thursday evenings from 6-8 PM starting June 20<sup>th</sup> through July 25<sup>th</sup>. Currently, staff is hiring for summer positions to supervise the summer programming. Cooley-Kistler suggested reaching out to the U of M to see if students could receive credit for

staffing the summer programming. Bradbury brings up the idea of having each commissioner volunteer one evening.

Nelson states she is looking into the Good Neighbor grant at the U of M. She has a meeting later this week to get more information. The goal is to use the grant for staffing costs. Nelson will let the commissions know if there is a need for volunteers. The hope is to get the word out about summer programming at Spring Together.

Nelson explains last year, the Ramsey County Sherriff, St. Paul Fire, and the Ice cream truck were present at Spring Together.

The commissioners discussed the budget last year and how to limit the number of repeat customers. There were 273 pieces of ice cream sold for a total of \$1,226.

Councilmember Leehy wonders if anyone from the U of M or the fair is invited to the event. We could potentially have a gardener come in and talk about planting ideas. Cooley-Kistler suggests the bee lady from the U of M.

Staff would like to reach out to apartments again, Stockford and Cooley-Kistler did apartment outreach last year and made meaningful connections.

Lundell brings up the idea of inviting the Horticulture Society. Leehy adds there is a resident on Tatum who works with seeds at the U of M. Stockford agrees he adds the resident focuses on hazelnuts. Van der Werff states the Environment Commission might have contacts to whom they could reach out. Stockford notes the event could be added to the Do Good Roseville and ISD 623 newsletters. The rental management companies will also send emails to all their residents promoting the event, they just need enough notice.

Leehy suggests reaching out to the Fit Lab. Nelson will reach out to the Lions.

Staff will work on a sign-up sheet to help with setting up, breaking down, and staffing tables during the event. The City has a tent to set up now and commissioners are asked to bring their tents if they have any.

Commissioners and staff discuss what table to set up at the event. The following are suggested:

- Community Park progress with a section where residents can provide input for an amenity they would like to see at Curtiss Field.
- Commission Information Table
- City/Check-in Table
- Environment Commission Table
- Summer Programming Table

Nelson wonders if the City should get a banner for Spring Together to promote this event, similar to the Ice Cream Social banner. Staff will also look into having a banner at City Hall. Nelson wonders about the cost of the banner. Stockford notes if the banner can be purchased for \$120 or less that should be ok. He adds that the Lions have a portable sign they use for their Christmas Tree sale.

Discussion of recommending budget for the event. Commissioners suggest a \$1,500 limit and after that point, the budget increase decision is the City Administrator's responsibility. It would be beneficial if there are other snacks available other than ice cream to also avoid repeat ice cream customers. Staff suggests having small bags of chips available. Ebbessen will connect with

Old Dutch and see if we can get chips for cost. Other items to consider are bubbles, sidewalk chalk, and a neighborhood map.

Bradbury suggests having music at the event this year like an open mic night but only for music. Yager and Benton will be in charge of getting the supplies needed.

The commissioners and Staff discuss the Ice Cream Social. It will be on Thursday, July 18 and the budget will be similar to last year. Ebbessen will reach out to Out on a Limb to see if there will be performers available. Cooley-Kistler wonders about having a dog parade again, if so, it would benefit from more announcements.

Staff notes each commission will have their April meetings separately and there will be a joint meeting on May 6. Stockford suggests having an e-mail update of where things are before the joint meeting and including clarifying questions/and or a check list.

### Neighborhood Liaison Handbook

#### Community Engagement Commission

The Community Engagement Commission (CEC) advises the City Council on matters related to human needs, public awareness or local concerns, and human rights issues. It seeks ways that encourages all citizens to participate in the civic and social life of the Falcon Heights. The commission helps plan and facilitate Human Rights Day, the Ice Cream Social, and such other public events as may fulfill its mission.

#### In the course of its mission it will:

- Recruit and retain neighborhood liaisons
- Identify areas with no liaison and focus recruitment efforts there.
- Update and distribute a neighborhood liaison handbook
- Implement appropriate Neighborhood Liaison training
- Provide suggestions on how to best communicate with the residents to keep our neighborhoods connected with city government
- Act as a resource for neighborhood activities
- Recognize and work to include renters and apartment residents in Neighborhood Liaison Program plans and activities
- Provide regular reports to the City Council on the Neighborhood Liaison Program
- Attend Neighborhood Liaison training sessions.
- Plan, implement and evaluate city-wide events to promote community building.
- Begin including Falcon Heights businesses in community engagement efforts.
- Annually elect officers and review CEC's mission and goals progress, establish goals for the upcoming year, and report these to the City Council at their annual retreat

## Community Engagement Commission Role in the Neighborhood Liaison Program:

The Community Engagement Commission (CEC) promotes opportunities for residents to be involved by endorsing and facilitating community outreach events. They will act as a human-bridge, defining ideas and activities that help to connect Falcon Heights City Council to the people they serve. The Commission will support the neighborhood Liaison Program and serve as a liaison between neighborhoods and the City Council. It will be the CEC's responsibility to refer concerns and recommendations that it receives from Neighborhoods through their Liaisons to the City Council for consideration.

#### What is a Neighborhood Liaison?

A Neighborhood Liaison is an extension to the Community Engagement Commission that formalizes a more localized outreach community engagement effort. They will provide a more familiar point of access to the assigned neighborhood community, while building and strengthening relationships. They will spend their time in the community talking with people, collecting suggested ideas, and forming relationships to keep the community connected.

#### Goals:

Curate relationships with neighbors to create safe spaces, safe streets and a welcoming community. Be a communication conduit between the city and your neighbors to help keep residents informed of important city updates and notify the city of concerns among a given neighborhood.

Connect individuals throughout the city that have already or are willing to develop a neighborhood network.

#### What does a Neighborhood Liaison do?

Help connect residents in your neighborhood by gathering and sharing contact information amongst neighbors.

Find ways to connect neighbors through gatherings of any size. These could include Night to Unite, block parties, cookie exchanges, happy hours, etc.

Receive and share regular updates from the city about upcoming city meetings and events, safety alerts and other news. If concerns or issues are raised in the neighborhood the Neighborhood Liaison can send information to the city.

#### Does it take a lot of work to be a Neighborhood Liaison?

Absolutely not! Many neighborhoods already have one or some people who already are connected on their blocks or neighborhood. We're want to connect with those individuals to be a point of contact for the city.

There may be occasions to gather liaisons to share concerns or success stories as a group but there will not be more that 3-4 voluntary meetings each year.

#### What kind of information is the city looking for?

The only contact information that the city will request is that of the individual(s) who volunteer to be connected with the city as a liaison. Any information gathered among neighbors will not be sent to the city, only shared with neighbors.

#### How will the city support the neighborhood liaisons?

The city will recommend communications, communication techniques and occasions to create neighborhood gatherings throughout the year. For some events the city may supply kits or supplies to help facilitate events.

#### Neighborhood Liaison Code of Ethics:

- Respect your neighbors
- Maintain a positive attitude and image
- Maintain local privacy of collected data
- Be a community builder
