BACKGROUND: On January 6, 2016, CV2 was involved in a traffic accident while responding to an emergency. This was the 2007 Tahoe scheduled for replacement this year. The insurance company made the determination that the vehicle was a total loss.

We purchased a similar "Emergency Services Vehicle" in 2015, which is our current CV1. At that time Council reviewed the recommended purchase and approved it on March 17, 2015. This vehicle was discussed again at the Special Meeting held on March 24, 2015. At this time the focus was on the color of the vehicle as a resident had raised the question of a red vehicle being safer. Chief Malmquist did a presentation on the history of the Duty Vehicle within Lake Elmo FD. Part of this presentation included information pertaining to safety and the color of Police/Fire/EMS vehicles. Studies had been done showing that color did not improve on the safety of the vehicle, but rather, emergency lighting and lighting patterns impacted safety and visibility. Council took no action and the vehicle was purchased.

ISSUE BEFORE COUNCIL: Replacement of CV2

PROPOSAL DETAILS/ANALYSIS:

Purchase of replacement vehicle through the State Contract, from Ranger GM in Hibbing MN, (state contract vendor). The LMC Insurance has determined the replacement value to be \$18,134.67. The LMC will also cover additional costs associated with getting the replacement vehicle equipped identical to the original. We will salvage and transfer as much equipment as possible from the old vehicle, to be reused. This includes lighting, radios, etc. We will also make some minor improvements to the overall safety of the vehicle. Currently we have two purchase options with the vendor: They have a new 2016 on the lot, ready for immediate delivery, or, if that is sold, we would order a 2017 with a 90 day delivery. The reason for purchasing this particular model vehicle, is that they are designed specifically for public safety use, with better brakes, better suspension, pre-wiring for emergency lights and several other minor modifications. The LMC will reimburse the City the \$18,134.67, less the \$1,400.00 salvage fee which will be paid to the City by the salvage company once transfer of equipment is completed and we release it. They will also cover the \$3,177.31 cost of transferring equipment as well as the \$220.00 cost of graphics.
