**AN ORDINANCE RENAMING A STREET IN THE CITY OF LAKE ELMO.**

**SECTION 1.** The City Council of the City of Lake Elmo hereby renames Stillwater Boulevard:

**SECTION 2.**

**Subd. 1.** For the purpose of this ordinance, the terms defined in this section shall have the meanings ascribed to them.

**Subd. 2. Existing Street Name.** The term existing street name shall mean the name by which a street is designated on the on the Washington County Highway and platting records.

**Subd. 3. New Street Name.** The term new street name shall mean the name by which a street shall be known from and after the effective date of this ordinance.

**SECTION 3.** The Existing Street Name of Stillwater Boulevard shall have a New Street Name of Stillwater Way N.

**SECTION 4.** The adjustment shall not affect the entire length of Stillwater Boulevard. The section which will be renamed is further described as North of the realigned Stillwater Boulevard/CSAH 14 and West of the realigned Stillwater Boulevard/CSAH 15 and is shown in Exhibit A.

**SECTION 5. Effective Date.** This ordinance shall become effective immediately upon adoption and publication in the official newspaper of the City of Lake Elmo.

**SECTION 6. Adoption Date.** This Ordinance 08-219 was adopted on this 2<sup>nd</sup> day of January 2019, by a vote of 3 Ayes and 0 Nays.

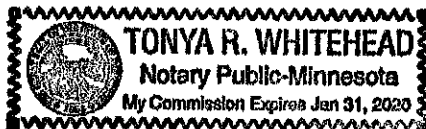
