SUMMARY AND ACTION REQUESTED: It is respectfully requested that the City Council receive a brief presentation by City Clerk Sharon Lumby regarding the official election results from the November 2nd, 2010 general election. Following this, it is respectfully recommended that the City Council undertake its legal obligation to canvass the election returns and certify the election results. The draft resolution to do so is attached, with a proposed motion of:

"Move to adopt Resolution No. 2010-061, A Resolution Canvassing the Returns and Declaring the Winners of the 2010 Local Elections"

BACKGROUND INFORMATION & STAFF REPORT: Under Minnesota Statute § 205.185 subd. (3), the City Council is required to canvass and certify the official results between 3 and 10 days following a regular election. As a result, a Special Meeting of the City Council is scheduled for Tuesday, November 9th, beginning at 6:30 PM, to certify the results of the municipal election and declare the results. A draft resolution is provided for Council Consideration.

RECOMMENDATION: It is respectfully recommended that the City Council receive a brief presentation by City Clerk Sharon Lumby regarding results from the November 2nd, 2010 general election and, following this, undertake action to canvass the returns and declare the winners. The recommended motion and resolution to do so is:

"Move to adopt Resolution No. 2010-061, A Resolution Canvassing the Returns and Declaring the Winners of the 2010 Local Elections"

Alternatively, the City Council does have limited authority under Minnesota Statute § 205.185 to further discuss and act on this responsibility. Should the Council desire to do so, additional legal

and procedural advice should be sought from the City Attorney and City Clerk. Should any changes be made following such action, the Council may elect to undertake the following:

<u>SUMMARY AND ACTION REQUESTED</u>: Pursuant to State law and following its September 2010 adoption of the *proposed* 2011 Budget, subsequent deliberations by and recommendations emanating from the Budget & Finance Sub-committee, and recent Council action to refinance outstanding 2004 G.O. Bonds, the City Council is asked to review and provide final direction regarding the preparation of the 2011-2015 CIP.

BACKGROUND INFORMATION: The City of Lake Elmo has both the legal and fiduciary responsibility under Minnesota State Statue to adopt a Capital Improvement Program (CIP). In September, the City of Lake Elmo adopted for submission to the Washington County Auditor the *proposed* 2011 general fund budget, as required under state law.

STAFF REPORT: City staff has prepared the proposed 2011-15 CIP for Council review and consideration at tonight's Workshop. The 2011 CIP is recommended significant programs and related expenditures emanating from Parks (Park Dedication Fees), Seal-coating and Transportation Improvements (General Fund, MSA Funds, Property Tax Levy and Special Assessments), specific public utility Improvements (revenue, reserves or other revenue sources).

The proposed 2011-15 CIP is also scheduled for review by the Parks Commission, Planning Commission, and Maintenance Advisory Commission.

State law requires submission to Washington County of the City's final 2011 Budget and 2011-2015 CIP by mid-December 2010.

RECOMMENDATION: It is recommended that the City Council consider and provide direction regarding the proposed 2011-15 CIP. However, it should be noted that the City may not increase its Tax Levy higher than that submitted to Washington County in September, thereby constraining somewhat major increases in the City's CIP without additional non-taxable revenues. It should also be noted that the CIP can be amended and/or modified by the City Council during the 2011 fiscal year.
