Due to Market Conditions, New home construction has tapered off at the end of 2022 and Spec Home starts have slowed. Some new plats did open up at the end of 2022, but weather conditions slowed starts also.

There was a significant increase in New Commercial Valuation and another area that saw an increase was Commercial Tenant Improvements/Buildouts/Alterations/Misc. with 74 permits for \$8,274,350 in valuations.

There were no new Multi-Family construction starts for 2022 but there is currently one building (190 units) in plan review for 2023.

There were 1064 Residential roofing permits pulled in 2022 for a total Valuation of \$24,888,196 and \$459,295 in Fees. Taking this into account the permit totals for the year would be about \$10,000,000 under 2021 totals if not for the weather event. These still amount to a large increase in overall totals for the year.

Notes: Staff have been very busy attending to the streets after many winter weather events. The two days following a snow event staff groom nature trails at Sunfish, Demontriville Wildlife, Pebble and Ried Parks, clear sidewalks abutting city properties, clear driveways at wells, towers & liftstation, clear city facility and park parking lots and clear the snow off the two rinks. Flooding of the rinks are typically done early morning before the sun get too high in the sky. Weather and higher priorities have made it a struggle to get good ice until after the new year. Water usage has dropped over 2 million gals per day after the irrigation season. Rough cut mowing of all city outlots and retention ponds was completed in October. Trimming of trees in the Road Right of Way is typically a winter project but has been minimal due to the number of snow events. Extra time was spent this fall sweeping chip sealed roads. PW Staff hauled tons of recycled asphalt saved from 2022 city street projects to the new city hall/fire hall parking lot, saving tens of thousands of dollars on gravel.




Lake Elmo Calls per Hour - October 2021 vs 2022



Lake Elmo Incidents per Month 2021 vs 2022





Investigations Spotlight: Welfare Fraud

The Washington County Sheriff's Office has a dedicated staff of detectives who work with all law enforcement agencies in the region to investigate crimes and apprehend suspected criminals. The investigations division addresses a wide range of crimes and quality of life issues throughout Washington County, utilizing several specialty units to concentrate on specific areas of criminal activity. In partnership with Washington County Community Services and other State agencies, our welfare fraud unit actively investigates suspected fraud both criminally and administratively in an earnest effort to protect taxpayer dollars.

The term "welfare" refers to a range of government programs that provide financial or other aid to individuals or groups who are unable to support themselves. These programs allow people to cope with financial stress during difficult periods of their lives, and eligibility is based on variety of factors, including family size, income, and lack of employment. Funded primarily through state and federal tax dollars, our welfare fraud detectives are responsible for protecting the integrity of these economic and medical assistance programs by investigating suspected fraud by individuals living in Washington County.

Fraudulent use of government assistance can be committed through a number of intentional acts, including under-reporting income, misrepresenting the number of children or adults living in the home, or falsifying documents. Working closely with Washington County Community Services, cases of suspected fraud are assigned to our welfare fraud unit through referrals from county caseworkers or tips from the public. Detectives will then review reports, conduct surveillance and online database searches, examine social media, interview witnesses, neighbors, and suspects, and review government records to determine if an individual wrongfully received assistance or intentionally applied for benefits through fraudulent means.



If detectives can prove through clear and convincing evidence that the fraud was intentional, the outcome would result in a disqualification of benefits and in more serious cases, criminal charges can be issued. When an individual is discovered to have wrongfully received assistance, they are ordered to repay the overpayment through payment plans, garnished wages, or forfeited tax returns. In the 2020-2021 fiscal year alone, our Washington County welfare fraud detectives recovered over \$490,740 in savings and \$986,033 in overpayments for a total of \$1.48 million – all taxpayer dollars.

The goal of welfare is to support families and individuals in need as they work towards a more secure financial life. Without enough income to provide a decent standard of living, these economic and medical assistance programs are designed to help individuals and families secure safe and clean housing, obtain access to medical care, purchase food, and provide financial assistance for daily living. Our Washington County welfare fraud detectives are dedicated to ensuring government assistance is allocated to those who truly need it - by preventing it from falling into the hands of those looking to exploit it.

On December 24th at approximately 1:30 am, the patrol sergeant on-duty came across a vehicle in the ditch on Highway 36 and Lake Elmo Avenue. When he went to check on the driver, he observed multiple signs of impairment including bloodshot eyes and slurred speech. The driver also admitted to drinking earlier in the evening.

With temperatures at -26 degrees, the sergeant limited the standardized field sobriety tests to the Horizontal Gaze Nystagmus test, (checking the eyes) and a preliminary breath test. The driver was ultimately arrested for driving under the influence and was found to have a blood alcohol level of twice the legal limit.






Lake Elmo Calls per Hour - December

Lake Elmo Incidents per Month 2021 vs 2022




