A Message from Mayor Cadenhead about the Proposed Site for a New Elementary School

I would like to shed some light on the process and considerations for the proposed site for a new elementary school that would replace Lake Elmo Elementary. The current school has served our community for over 100 years, and I am in support of building a new facility to provide a better learning environment for our students. Because of the complexity of multiple factors in play, we must understand the process, roles, responsibilities, and considerations that lay ahead.

Discussions / Process Thus Far

The School District, Lake Elmo City Staff, and members of the Council, had two meetings prior to the bond vote to discuss potential sites that could fit the needs for a new Elementary School to replace Lake Elmo Elementary. While all the sites identified during that discussion have possibilities, the School District needed to make a decision based on what was known at the time. As with any development project, stakeholders may be aware of some issues, but until due diligence is completed, the exhaustive list cannot be known.

Of the four sites they considered, we discussed known contamination issues, water and septic considerations, potential traffic impacts, and dependencies on other development projects which will be explained in more detail below. Additionally, School District 834 has expressed interest in building the

new school further south due to housing growth in the southern part of our district and the future impact on the student population. Based on all of these factors, the School District felt the best location for the new school was on the northwest corner of Lake Elmo Avenue and 10th Street. Voters were informed of the intent to build in that location, a sign was posted on the parcel, and the referendum passed. At this time, the School District has indicated that they do not have any other locations in Lake Elmo under consideration.

It may seem as though this process is taking a long time. The process is being followed as it should with any development within the city to make sure that proper items are addressed between the developer and the city.

Process & Role Clarity

It is known there are concerns about traffic, the proximity to the Oakdale Gun Club, access to water and sewer, and a potential loss of trees on the corner of Lake Elmo Avenue and 10th Street. It is helpful to understand the responsibilities of the City and also the developer (The District) to provide role clarity. Not only does this help us proceed with intentional conversation, but it also aligns with our obligations to each other and the community.

As the project owner, The District is responsible for assessing and mitigating issues related to their development project. This could include factors such as the layout of the building, proximity to the gun range, the up-front and on-going expenses of the project, etc.

The city will, in turn, work with the school district through navigating the requirements to re-zone the land, how to comply with city ordinances just as it would be needed in any other municipality. While the City Staff and Council members can share insights about different parcels of land, it is ultimately the district's decision about how to proceed – as long as the process steps are met.

With that, there are a few complicating factors that we will need to work through together. It is important to me as the Mayor of Lake Elmo, to educate our community about the various agencies and processes that we need to comply with. This is challenging, that's for sure. But it can be done.

MUSA - In addition to City Zoning and City Code compliance, we also are governed by the Metro Utility Service Area (MUSA). The MUSA is governed by the MET council. They operate the sewer system for the entire metro area. To have a connection to sanitary sewer, as opposed to a self-contained septic system (Oakland Junior High runs on a septic system), a building needs to be within the MUSA boundary. Lake Elmo's MUSA boundaries can be found in the 2040 Comprehensive Plan here: https://www.lakeelmo.org/departments/planning zoning/comprehensive plan.php#outer-28.

Zoning - To build a new school, any parcel of land in consideration would need to be zoned as 'Institutional.' Right now, the parcel of land slated for the new elementary school is zoned as agricultural. For a zoning change or a MUSA boundary change, at the City Council level, there needs to be a motion and super majority vote to accomplish the changes at a City Council meeting. This means that the Lake Elmo City Council would need 4 out of 5 members to vote in the affirmative to make a change to the MUSA and/or the zoning designation. Please note the zoning change would be needed for any location that the district would have chosen for an elementary school site.

Technical Considerations – If approved, the realities of the site and the complexities are something that the City and School District have been working on finding solutions to and work through.

- 1 Roadway improvements to CSAH 17 (Lake Elmo Avenue) and CSAH 10 (1th Street) will need to be made to maintain safe traffic flow. Many schools throughout the country are on busy roadways. In fact, the average daily traffic on Stillwater Blvd, in front of the current school, is currently higher than the average daily traffic on 10th Street. With this potential development, Washington County does not have anything in their Capital Improvement Plan (CIP) for work on the roadways in that area at this time.
- 2 Sewer hook-up (MUSA) or a septic solution (outside of MUSA), are not as easy as it may seem on the face of it. The sewer that was installed along Lake Elmo Avenue to serve the MUSA area in the Old Village area is active north of 30th Street and then is a force main to a manhole all the way south to \$\frac{\pi}{5}^h\$ Avenue (south Cimarron). To bring sewer to the NW quadrant of CSAH 10/CSAH 17 about 4000' of pipe and a lift station would need to be installed. This would be at a cost of about \$1.1 Million and would be a developer cost.
- 3 I don't have an answer on how the School District plans on abating the noise from the Oakdale Gun Club. The primary note is to make sure that the development does not negatively affect the gun clubs ability to operate as they have for many years.
- 4 The loss of trees has been discussed. From The City's perspective, the development of that area would need to comply with the ordinances of the City just like any other development.

Current State / Looking Ahead

As previously mentioned, zoning change and MUSA boundary are the first two items to get determined by the city to make it possible for a public institution use. On Monday 2/12/24, after a lengthy discussion, the

Lake Elmo Planning Commission voted to not recommend a change to the zoning for the proposed site or include the parcel in question as part of the (MUSA). The Council reviews their recommendation in terms of its impact to MUSA and zoning designation and will vote on the proposed changes.

Because I, along with other stakeholders, are also members of this community, it is critical that we have role clarity and are acting on behalf of the elected or appointed role that we play. I am grateful that we all care about doing the right thing. All of these things together, ensure we make the best decision long term – for our community as a whole.

This complex situation is going to require measured and thoughtful problem-solving. It requires that we keep a level head and uncover/evaluate all potential issues, possibilities, roadblocks, and long-term considerations. It requires a strong partnership and clear communication. As the mayor, I am committed to working with our partners to strive for a win/win situation as it relates to development in Lake Elmo. In the meantime, I hope to hear from community members and stakeholders — to listen to your requests and discuss your concerns. If this type of work interests you and you are a resident of Lake Elmo, please consider serving on one of the Commissions/committees in the city. These events are free and open to residents and businesses. Limit: 6 boxes (weighing no more than 30lbs each) per person.




Garbage/Recycling Containers



Please Do Not place garbage cans

in the street. We realize this cleared area is an enticing location to place garbage cans, but they create hazards as they narrow the driving lanes, restrict visibility of pets, children, pedestrians and cars backing out of driveways. Most garbage trucks are equipped with a hydraulic extending arm that grasps garbage cans. It is recommended that garbage cans be placed at least 3 to 5 feet off the edge of pavement, into your driveway, so they are out of the way of the snowplow or snow being pushed aside while the snowplow

Exterior storage, parking and maintenance

As part of our ongoing efforts to maintain the appeal and safety of the City of Lake Elmo, city staff would like to remind residents about regulations pertaining to exterior storage, parking, and upkeep of properties. The way we manage our spaces is important for maintaining our city's quintessential character.



Exterior Storage: All refuse, rubbish, or garbage (as defined in LEC 1.08) shall be kept in an enclosed building or properly contained in a closed container designed for the purposes. The accumulation, storing, or keeping of old machinery, wrecked or inoperable vehicles or household appliances, and unlicensed vehicles and other junk or debris is prohibited.

Parking: Unlicensed passenger vehicles and trucks shall not be parked in residential districts for a period exceeding seven days.

Parking Design and Maintenance: Surfacing and drainage. All off-street parking areas shall be surfaced as follows: Single-family and two-family dwellings shall provide a durable surface with suitable drainage. In all residential, commercial, and mixed-use districts, all areas intended to be utilized for parking space for five or more vehicles and associated driveways shall be paved with a durable surface, including, but not limited to, hot asphalt, bituminous or concrete.



The City of Lake Elmo has been working with Washington County and their environmental specialist to incorporate recycling efforts in our downtown area and at the new City Center. A grant provided by Washington County offered the city an opportunity to place bins throughout downtown, Lions Park and VFW Field, and at City Hall. These bins will help promote recycling throughout the area and can help reduce waste up to 60% in common areas.

A few words Carbon Monoxide

Carbon Monoxide:

- is a deadly gas created by incomplete combustion and is found in vehicle exhaust.
- Has no color, odor, or taste which makes it impossible to recognize without detection equipment.
- Is often found in homes with faulty gas fired appliances.



We recommend that:

- You never run a vehicle inside a garage, even with the garage door open.
- Have Carbon Monoxide detectors on every level of your home, within ten feet of sleeping areas.
- You purchase a stand alone Carbon Monoxide / Combustible Gas detector that
 plugs into the wall, has a digital display, and battery backup for installation in
 mechanical rooms.

Carbon Monoxide poisoning is dangerous. Symptoms include:

- Weakness.
- Drowsiness.
- Headaches.
- Confusion.
- Shortness of Breath.

If you experience these symptoms or your Carbon Monoxide alarm sounds, call 911 immediately.

Emerald Ash Borer

Washington County will remove ash trees from Lake Elmo Park Reserve

Washington County is continuing ash tree removal within Lake Elmo Park Reserve in response to the emerald ash borer. Starting Nov. 15 through March 31, 2024, ash trees will be removed near trails and in natural areas of the park. These removals will help minimize risk to the public from falling trees and will also reduce fuel loads that can increase fire risk within the park.

To complete the work, a contractor will be using equipment to cut and haul the trees to staging areas, before chipping and removing debris from the site. Once work commences, ski trails on the south side of Lake Elmo and the snowmobile trail will be closed. Only ash trees will be removed, and new bareroot trees will be planted in suitable areas in the spring of 2024.

See the county website at to view a map of ash trees. Green dots are trees to be removed, and purple dots are ash trees surveyed in summer of 2023. If time and weather conditions allow, staff will also remove dead or dying ash trees along the property boundaries.


