BACKGROUND:

The Lake Elmo Baseball Association has been the primary user of both Lions and VFW ballfields for youth recreational baseball practice and games. Recently the association reached out and asked about upgrading the scoreboard at Lions Park due to its age and adaptability.

ISSUE BEFORE THE COMMISSION:

Would the Parks Commission like to recommend to City Council to accept the donation of a new scoreboard at Lions Park Ballfield with an approximate value of \$15,000 from the Lake Elmo Baseball Association?

PROPOSAL DETAILS/ANALYSIS:

The Lake Elmo Baseball Association has made a request to donate a new scoreboard to be placed at Lions Park. Upgrading the scoreboard will bring a new updated look to the field and allow users to control the scoreboard via an application from a controlled device. The current scoreboards were manufactured in 2007 and depending on weather and location have a life expectancy of 10-15 years.

Parks Commissioners should consider the following when accepting donations:

- (1) Is the gift of lasting value to the community?
- (2) Does it create potential liability issues for the City? That is, will people walk on it, sit on it, or under it? Will construction be inspected, is construction up to current standards (ADA accessible, for example?) Are the materials used acceptable for public construction?
- (3) Will some member of the public find the item offensive; can it be construed as having a religious content, or offending members of a protected class?
- (4) What will the potential annual maintenance cost of the gifted object be? Do the costs outweigh the value of the gift?
- (5) Does the gift carry implied duties that the City must perform? What is the cost of performance of such duties? Does the cost exceed the value of the gift?
- (6) If costs, direct or indirect exceed the value of the gift; acceptance of the gift may still be warranted if a public purpose is being served and all understand the costs as well as the value of the gift.

- (7) Also, does the acceptance of the gift imply that the City will replace the gift when worn out, destroyed by vandals, etc? If the gift is found to be no longer of use in the future, may the City at that time, sell, dismantle or convert to another use?
- (8) All agreements, prohibitions, etc, with respect to the gift should be noted in the minutes or Memorandum of Agreement for future reference.

FISCAL IMPACT:

The proposed scoreboard would be purchased by the Lake Elmo Baseball Association and donated to Lions Park. Public works would help with removal and installation of the new scoreboard. Cost of and electrician to hook up and install any electrical components is expected and would be funded through the public works budget.

OPTIONS:

- 1) Approve the donation of a scoreboard to be place at Lions Ball Field from the Lake Elmo Baseball Association
- 2) Do not accept the donation from the Lake Elmo Baseball Association

The Parks Commission should identify any agreements or exclusions related to the recommendation.

RECOMMENDATION:

Staff recommends the following motion:

"Move to recommend to the City Council to accept the donation of a new scoreboard to be placed at Lions Ballfield from the Lake Elmo Baseball Association."

BACKGROUND:

The Friends of Sunfish along with Tony Manzara are looking for the Parks Commission's support to submit a letter of intent for funding to improve and enhance outdoor recreational opportunities in our community.

As part of the 3M settlement, \$20 million in grant money was set aside to compensate for losses to recreational and ecological resources resulting from PFAS released by 3M. The DNR and MPCA have elected to solicit project proposals directly from the organizations and communities via a public RFP process. The first part of the process is for the organization to submit a letter of intent. After review of all letters, this will be followed up with a full application of the proposed project. The Friends of Sunfish are asking for the support of a letter of intent for a boardwalk in Sunfish Park.

ISSUE BEFORE THE COMMISSION:

Would the Parks Commission like to recommend to City Council their support for the Friends of Sunfish and their letter of intent to apply for the Priority 2/Goal 3 settlement?

PROPOSAL DETAILS/ANALYSIS:

The Friends of Sunfish with the support of the Parks Commission and City Council would like to write a Letter of Intent for a boardwalk they would like constructed in Sunfish Park. The letter of intent would be reviewed by the DNR and MPCA along with all other applicants for a sum of money which has been allocated strictly for enhancing outdoor recreational opportunities. The application for Part 1; Letter of Intent, is expected to open this fall and will be open for all applicants for 30 days.

The proposed project will consist of a 270 foot boardwalk which will cross the North end of Sunfish Lake. The project is expected to cost \$500,000 and will provide a connection between two dead end trails.

FINANCIAL IMPACT:

At this time there are no financial obligations being sought from the City of Lake Elmo.

RECOMMENDATION:

Staff recommends the following motion:

"Move to recommend to City Council support for the Friends of Sunfish to submit a letter of intent for the boardwalk project through the Priority 2 settlement."

BACKGROUND:

The City of Lake Elmo has acquired a 29 acre parcel in connection with the Northstar Development which was approved by City Council in 2023. The newly acquired land is mostly wooded and abuts up to Sunfish Lake. The properties location is about one mile from the downtown area.

With the intent of the park opening in 2025, staff has offered up the opportunity for community members to provide name suggestions for the park.

The community was given the opportunity to submit naming suggestions at the National Night Out event held in August. In addition to the event a link to provide naming suggestions was posted on city's web page and Fresh newsletter. Overall a total of 40 suggestions were received over a 30 day period.

ISSUE BEFORE PARKS COMMISISON:

What name would the Parks Commission like to recommend to City Council?

PROPOSAL DETAILS/ANALYSIS:

Staff has put together the list of the names that were suggested by the community, all duplicate names were only listed once. The Parks Commission should review the park naming policy that was created in 2019 for the purposes of naming city parks.

FISCAL IMPACT:

There is no financial cost of naming the park.

RECOMMENDATION:

Staff suggests a unique name based off the parks location in the city. Staff suggests providing 2-3 names to bring to City Council for Consideration.

City of Lake Elmo Policy and Procedure for Naming City Parks, Trails, Recreational Areas, and Facilities

Purpose:

The purpose of this policy is to establish a standard procedure for the naming and renaming of parks, trails, recreational areas and facilities owned and/or operated by the City of Lake Elmo. This policy will guide name recognition and establish a uniform process. The Parks Commission shall be responsible for providing a recommended name to the City Council. The City Council will have the final say for the approved name.

Objectives:

- To name City parks, trails, recreational areas and facilities with the intent of enhancing the community by provoking a sense of place.
- Ensure that parks and recreational areas are easily identified and located with names that are consistent with the values and characteristics of the City of Lake Elmo.
- Assure the quality of the title/name, so that it will serve the purpose of the City in a permanent manner.
- Encourage public participation and input in order to fully represent the best interest of the community.

Criteria for Submitting a Name:

When a proposed name is presented for review, City Staff will first vet the name against the criteria listed below. If a name does not fall into one of the categories listed below or is deemed to be derogatory or offensive in nature, the consideration will be thrown out. It should also be known that the City will not consider names that are directly named after a specific neighborhood or subdivision.

The Park name shall not:

- Park Names shall not be duplicated.
- The City will not name parks directly after a development.
 - For example, the park within Wildflower shall not be called Wildflower Park. However, rose park, fox glove park, etc. would be acceptable.

Categories for potential park Names:

- An outstanding feature of the area. (example: hill, river, vegetation)
- Geographical location of the park such as a street name.
- Naming after an individual (living or non-living) or organization. The City may require additional information to further enforce that the individual has significantly contributed to the improvement of the Lake Elmo Parks system.
 - A person (living or non-living) or group who significantly contributed to the acquisition or development of park/facilities, who provided an exceptional service in the interest of the park system, or for the community as a whole. When naming after a person or persons, written documentation of approval by next of kin is required (if available/possible) as part of the proposal.
 - A standard for significant contribution shall consist of providing at least 50% of the cost to develop or acquire the land.
- The City understands there are other categories that a name could be pulled from and would not exclude its consideration.



Procedure:

The City has created a process that will provide consistency for naming or re-naming City Parks. In general a submission will come in, go through staff review and approval, undergo a Parks Commission review, and end with final approval or denial from the City Council. The City would like to encourage residents to stay interested and voice their opinions during the meetings when the name is being considered.

- Step 1) At the time that the City is ready to name or rename a park, notification will be put in the Fresh, City Facebook, and or use other measures as appropriate. The City will seek name suggestions from the City Council or Commissions, City residents, Community leaders or organizations interested in proposing a name for a park, trail, recreational area or facility. The applicant should either request a Naming Policy form from the City Clerk or download the form from the City Website on the Parks page. After the form has been filled out it will need to be submitted to the City Planner to review against the criteria. Once the timeframe for receiving names has closed, Staff will begin the review process.
- Step 2) Staff will notify the applicant if the proposed name has or has not met the requirements. After a proposed name has been approved by Staff, the applicant will be informed when the name is going to be discussed by the Parks Commission. After the Commission discussion, the recommendation(s) will move onto the City Council for final approval or denial.
- Step 3) Once the City Council votes to approve a name, the name of the park shall be confirmed by passing a resolution.

Renaming:

The intent of naming is for permanent recognition, the renaming of parks and facilities is discouraged. Though, the City understands that renaming a park, trail, or facility may be necessary to create more cohesiveness throughout the City. It is recommended that efforts to change a name become subject to crucial examination so as not to diminish the original justification for the name or discount the value of the prior contributors. Renaming a park will follow the same procedure stated above.

BACKGROUND:

With the construction of the new Northstar Development, the city received 29.9 acres along with \$218,876 in park dedication funds. Beginning in the fall of 2024 staff is looking to construct a nature trail through the property. Staff is looking to furnish the park a standard City Park Sign, benches and trash receptacles upon opening of the park.

ISSUE BEFORE COMMISSION:

Would the Parks Commission like to recommend to City Council the recommendations and cost projections for the construction of the park?

PROPOSAL DETAILS/ANALYSIS

Staff has suggested the following items at the park upon completion of construction. All of the work will be completed by city staff starting in the fall of 2024.

The following items are being proposed for the new park:

<u>Park Sign:</u> Purchase of a park sign, to be placed at the park entrance. This sign will be consistent with our other city park entrance signs and will be installed by staff.

Benches: Consistent with other City Parks, up to four benches will be installed along the trail.

Concrete: Concreate will be purchased to make footings and anchoring for up to four proposed benches.

<u>Garbage Cans:</u> Two additional garbage cans are being recommended at this park location, current cost of trash receptacles are \$600 apiece.

FISCAL IMPACT:

The building of the newly constructed park is expected to be completed in the spring of 2025, with funds coming directly from the Parks Dedication Funds.

RECOMMENDATION:

"Motion to recommend to city council the proposed purchases by city staff to furnish the newly constructed park."
